the Road, they isid all their Oars across, except two in each Boat, which they muffled with Bayes, to prevent their being heard at a Distance. They rowed in that Manner till they were within Musket-shot of the Privateer; and, being haled, they made no Answer; but in a few Minutes boarded him on both Sides, and took Possession of him without the Loss of a Man, and only two were wounded. Mr. M'Bride shot the Lieutenant of the Privateer through the Head with a Musket, as he was pointing a Gun into the Boat; and one common Man was killed, and five wounded. This was done within half Gun-shot of a Fort on the East Side of the Harbour, but the Fort did not fire at them; and when the Prisoners were fecured, they cut the Cables, and failed out of the Road.
