For giving Encouragement to Seamen and Able-bodied Landmen to enter themselves on Board His Majesty's Ships of War; and for granting Rewards for dif-covering fuch Seamen as shall conceal themselves.

HEREAS for the speedy Manning Our Fleet, We did, by Our Royal Procla-mation bearing Date the 22d Day of July last, Promise and Declare, amongst other Things, That the Bounties of Five Pounds for every Able Seaman, and Thirty Shillings for every Ordinary Seaman, should be paid to every such Able and Ordinary Seaman, not above the Age of Fifty, nor under the Age of Twenty Years, who should, on or before the 12th Day of September then following, enter themselves to serve in Our Royal Navy, either with the Captains or Lieutenants of Our Ships, or the Chief Officers on Board such Tenders as should be employed for Raising Men for the Service of Our Royal Navy; and that a Bounty of Thirty Shillings should be paid to every Able-bodied Landman, not above the Age of Thirty-five, nor under the Age of Twenty Years, who should, on or before the said 12th Day of September, in like Manner, voluntarily enter themselves to serve in Our Royal Navy; and that a Reward of Two Pounds for every Able, and Thirty Shillings for every Ordinary Seaman, should be paid to any Person, who should discover any Seaman or Seamen, who should secret themfelves, fo that such Seaman or Seamen should be taken for Our faid Service: Which faid Bounties and Rewards have been continued by Our Orders in Council from the faid 12th Day of September to the 31st Day of last Month.. And whereas many Men are fill wanting to compleat the Complements of Our Ships now fitting out for Sea, We do therefore hereby Promife and Declare, That, for the better Encouragement of all fuch Seamen, Seafaring Man, and Ablebodied Landmen who shall voluntarily enter them-selves into Our Service, the Bounties of Six Pounds for every Able Seaman, and of Three Pounds for every Ordinary Seaman, be paid to every such Able and Ordinary Seaman, not above the Age of Fifty, nor under the Age of Eighteen Years, who shall, on or before the 31st Day of March next, voluntarily enter themselves to serve in Our Royal Navy, either with the Captains or Lieutenants of Our Ships, or the Chief Officers on Board such Tenders as shall be employed for Raifing Men for the Service of Our Royal Navy; And also that a Bounty of Thirty Shillings be paid to every Able-bodied Landman not above the Age of Thirty-five, nor under the Age of Eighteen Years, who shall, on or before the fall 31st Day of March next, voluntarily enter themselves in like Manner to serve in Our Royal Navy; And that fuch respective Sums be paid to all such Seamen and Landmen immediately upon their Entring, by the Officers, employed in Raifing Men for Our Fleet, with whom such Seamen and Landmen shall respectively enter. And we do further Promise and Declare, That a Reward of Five Pounds for every Able, and Two Pounds Ten Shillings for every Ordinary Seaman shall be paid to any Person who shall discover any Seaman or Seamen who may secret themselves, so that such Seaman or Seamen

shall be taken for Our faid Service on or before the faid . 31st Day of March next, by any of Our Sea Officers employed for raising Men; the said Rewards to be paid for any Seaman or Seamen to discovered and taken in and about London, by the Principal Officera and Commissioners of our Navy; and at the Out-Ports, by the Naval Officers where there are any, and where there are no Naval Officers, by the Collectors of Our Customs, immediately upon a Certificate being produced to the said Principal Officers and Commissioners of Our Navy, Naval Officers, or Collectors of Our Customs respectively, by the Person who may make Discovery of any Seaman or Seamen as aforefaid, certifying his Name, and the Name or Names, and Number of Seamen procured in Consequence of his Discovery; and the faid Certificate to be given by fuch Officer as may take fuch Seaman or Seamen for Our Service.
