should be Prisoners during the War, and secure in their Possessions and Effects. His Majesty's Sloop Gramont, and several other Vessels, were taken by the Enemy in the Harbour of St. John's.

Constantinople, May 3t. His Excellency Mr. Grenville, His Majelly's Ambassador to the Ottoman Porte, had his first Audience of the Grand Seignor on the 11th Instant, in which he presented His Majesty's Letters of Credence, and was received with all the Pomp and Ceremony usual on these Occasions. His late Excellency Mr. Porter set out from hence with his Family, by Land, on the 24th of this Month, in his Way back to England. A terrible Fire broke out here lately, and continued burning very fiercely for Twenty-four Hours; the Number of Houses burnt down is computed to be near Five Thousand. The Capitan Pascha, Chief Admiral, is upon the Point of failing for the Archipelago, according to annual Custom, and goes out

with five Men of War and fix Galleys.

Turin, June 26. The King of Sardinia has been lately indifposed by an Ague; but, by the Application of the Bark, his Mojesty missed the Fit Yesterday, and is judged by his Physicians to be in a very

good Way of Recovery.
