Cologne, November 26. Twenty Battalions and Thirty Squadrons of the Prince of Conde's Division, commanded by the Marquis de Monteynard, separated the 17th from the Army in Falle, and marched to the Lower Rhine. The Avant Guard arrived here last Wednesday. Yesterday the Head Quarters were in this Town, where they will continue till the 28th, when they will be transferred to Dusseldorff.

The Regiment of Champagne is here; Anhalt, Baviere, and Vierzet, at Welel; two Battalions of Piedmont at Cleves; one at Calcar, and the other at Rees; Bouillon, Lockman, and a Battalion of Militia at Duffeldo. A: Reding at Guaidres; Arbonnier at Urdingen; the Royal Artillery at Neufs; the Dragoons of Chapt at Cleves, and in the Neighbourhood; Flamarans at Orfoy; Schomberg at Akkirk, and the Light Troops at Rees, Zanten, and Wesel. If the Regiments were compleat, they would amount to 27,000 Men.
