Count Pignatelli, his Sicilian Majesty's Minister at this Court, who has waited some Time for the Arrival of his Successor Prince Sanseverino, fat out on Saturday for Turin, to reside there on the Part of his Most Faithful Majesty. Prince Sanseverino and his Lady arrived in Town on Sunday.

His Britannick Majesty's Ship the Juno, Captain Falkner, is upon Departure for England; and the Lark, Captain Thompson, who arrived a little Time ago from Newfoundland; will fail in about ten or fifteen Days.

M. de Mello, who is gone to Villa Viciosa for eight Days, intends to take the Opportunity of embarking on Board His said Majesty's Ship the Lark.
