Genoa, December 17. This Day the Republick, as usual, began to ballot to chuse the Two Hundred Members who are to compose the Small Council for the next Year.

Copenhagen, December 24. The contagious Diftemper, which broke out lately among the Horses, feems now to be entirely stopt; but that of the Horned Cattle still rages without Intermission. that it had penetrated into Norway by means of a Transport of Cattle from hence, and had reached some Places near Christiania; but that the Governor of the District, by taking proper Precautions, prevented it from spreading; so that after having carried off about Forty Head, the Distemper ceased.
