Westminster, January 25. HIS Day His Majesty came to the House of Peers, and being in His Royal Robes feated on the Throne with the usual Solemnity, Sir Septimus Robinson, Knt. Gentleman Usher of the Black Rod, was sent with a Message from His Majesty to the House of Commons, commanding their Attendance in the House of Peers. The Commons being come thither accordingly, His Majesty was pleased to give the Royal Assent to,

An Act for exhibiting a Bill, in this present Parliament, for Naturalizing his Highness the Hereditary Prince of Brunswick Lunenburg.

An Ast for punishing Mutiny and Defertion; and for the better Payment of the Army and their Quarters.

St. James's, January 28, 1764. Hereas, notwithstanding the repeated Notices, which have been published in the London Gazette, the Merchants and other Persons having Effects in any of the several Islands or Places restored to the Crowns of France and Spain by the late Treaty of Peace, and having a Right to fend Ships thither to bring away such Effects, pursuant to the 8th and 19th Articles of that Treaty, do nevertheless neglect to deliver into the Office of the Earl of Halisax, His Majesty's Principal Secretary of State, a Designation in Writing, figned by their Names, of the Ships proposed to be sent by all and every of them, either jointly or separately, with the Name and Tonnage of each, and the Time within which they are intended to sail to any of the said Islands or Places: And whereas it is now become necessary to fix a certain Time, beyond which the Applications to be made by His Majelly's faid Secretary of State to the Courts of France and Spain, for the Delivery of the respective Passports, agreed by the said Treaty to be given to the said Vessels, cannot be delayed, without Danger of much Prejudice, and Inconvenience, to the Interests of the Concerned; It is therefore hereby proposed and desired, that the said Merchants and others, would deliver in the Designations of their respective ships, in the Manner above described, to the Office of His Majesty's said Secretary of State, before the 14th Day of February next; and they are further to take Notice, that no Regard will be had to any Applications of that Nature, which may be delivered into the faid Office, after the faid 14th Day of February, except in such Cases where the faid Notice shall appear to have been delayed by fome unavoidable Circumstance or Accident.

Genoa, December 31. The Duke of York continues to enjoy a perfect good State of Health, and partakes of the Amusements given by the Republick, who endeavour to make this Place as agreeable to his Royal Highness as possible.

Petersburgh, December 27. Count Salken, Envoy from Saxony, is arrived here. The Great Duke is

Genoa, January 7. 'The Plague having broke out, and raging violently at Spalatro, the Magistrates of Health of this City have this Day refolved, that all Vessels coming from the Coast of Dalmatia shall perform a Quarantine of 60 Days, after having been

fent to Porto Spetia, to lye there Ten Days, in O.der to air the Vessel and Goods.

Venice, January 6. This Government has received Advices from Dalmatia, that the Plague broke out in the Suburbs of Spalatro, about the 23d of December, supposed to be brought thither by some Contraband Hides. The last Accounts say, that about Eighty Persons had died of it; and that the General of Dalmatia was arrived there, and had inclosed the Suburbs, and prevented any Person's coming out of those Precincts, by a constant Guard. The great Care and Precautions taken by this Republick on these Occasions, it is hoped, will prevent the Dis-

ease from dilating itself farther in this Country.

Turin, January 7. The Marquis de St. Germain, whom the King of Sardinia had lately appointed his Minister in the Department of Foreign Affairs, died

here a few Days ago.

Ratisbon, January 9. The Imperial Ministers have at last, by Order of their Court, returned the Minister of Salzbourg an Answer to the Remonstrance which he made to them in the Name of the College of Princes, concerning the Participation which they require in the Affair of the Election. This Answer, which the Minister of Salzbourg has just communicated to the other Princes Ministers, is as follows: "That His Imperial Majesty was then employed in finding out an Expedient for the Content and Con-" folation of the Princes of the Empire, relating to the Election of a King of the Romans, without Prejudice to the Electoral College, and confequently of such a Nature as to avoid all Collision between them."

The Ministers of the Princes have defired the Minister of Salzbourg to use, at this Juncture, his utmost Endeavours, that the Expedient, which his Imperial Majesty intends to propose, may be put in Execution in Time; and the said Minister has assured them, he has already folicited the Con-Commissary very strongly, that this Affair may be decided before

the Opening of the Electoral Diet.

Liege, January to. Last Sunday Count Toering,
Minister from the Elector of Saxony, and the Canons
attached to Prince Clement of Saxony, received
Letters from his Royal Highness, informing them
that the Pope had at last decided the Cause, so long depending at Rome between him and Count Oultremont, in Favour of the Latter: That he was, however, equally obliged to those, who had been his Friends, and should be ever ready to give them Marks of his Favour. Yesterday Morning Count Toering fet out from hence for Freyfing; and in the Afternoon the Canons that had voted for Prince Clement, waited on Prince Oultremont, now Bishop of Liege, and were very graciously received by his Highness.

Berlin, January 14. M. Gadomski, Envoy from the Republick of Poland, arrived here last Week, and on the 8th Instant, he had a Private Audience of the King of Prussia, to notify the Death of the King of

Poland. Prince Ferdinand of Brunswick came to this Place the 7th, and is thought he will pass the Remainder of

the Carnaval in this Capital.

John Adolph, Third Son of the Reigning Prince. of Nassau Saarbruck Ussinzen, who had the Rank of Marechal de Camp in France, has entered into the

King of Prussia's Service as Major General, and has besides the Command of a Regiment of Infantry,

formerly Grabow.

Bonn, January 12. The States, that were affembled here, broke up Yesterday, after having granted the Elector a Subsidy of One Hundred and Sixty-six Thousand Crowns. This Morning, about Six o'Clock, the Elector fet out for Munster, to assist at the Assembly of the States there, as several very important Points, which require his Electoral Highness's Presence, are to be regulated; however, as the Court is preparing magnificent Equipages for Frankfort, it is generally believed his Electoral Highness will return in less than six Weeks.

Translation of the Information received the 5th of January 1764, from the Magistracy of the Health Office, by John Udney, Esq; His Britannick Majesty's Consul at Venice.

OUR Magistracy enjoyed a perfect State of Tranquility, after having received repeated and certain Notices, that at Abbadesia Castle, since the two Accidents formerly related, nothing new had hap-pened to cause any Suspicion; but, on the contrary, that the surviving Persons of that insected Family were in compleat Possession of their Health; when, on a sudden, these Days past, we received the disagreeable News, that in the grand Borough of Spalatro, for some Time, Distempers had subsisted, accompanied with acute Fevers and the Measles. Finally, on the 19th of December last, on the Examination which was made on Four Corpfes, of the Number of the Ten Persons, that died on that Day, such strong Tokens of a contagious Distemper were discovered in the most suspicious Parts of the said Corpses, that the Doctors of Physick residing there made no Scruple to give it that Determination. Upon the first Notice thereof, his Excellency the Proveditor General Michiel departed from Zara, and repaired to the Place, provided with the proper Authority for doing every Thing necessary in an Emergency of so very great Importance.

By reason of the already related Accidents which happened at Abbadessa Castle, Dalmatia, together with all the adjacent Islands, is subjected to 40 Days Quarantine, as you well know; so that now all that remains to be done, is in Addition to the provided Measures hitherto taken, to apply others sufficient for Security against so great an Emergency. Of what further Accounts we may receive from the General after he shall have made the strictest Examination on the Spot, we shall immediately give you the fullest Information, as is requisite in a Matter of so much Importance, and to give you a fresh Proof of our constant and sincere Correspondency.
