The KING's most Excellent Majesty in Council.

**T**HIS Day the Right Reverend Richard Lord Bishop of London was, by His Majesty's Command, sworn one of His Majesty's most Honourable Privy Council, and took his Place at the Board accordingly.

This Day the Honourable Robert Walpole, Esq; was, by His Majesty's Command, sworn one of the Clerks in Ordinary of His Majesty's most Honourable Privy Council, upon the Resignation of Henry Fane, Esq; And Richard Orlebar was likewise, by His Majesty's Command, sworn one of the Clerks of His Majesty's most Honourable Privy Council in Extraordinary.

And to grant unto Thomas Wilson, Doctor in Divinity, the Place and Dignity of Dean of the Cathedral Church of Carlisle, void by the Resignation of Doctor Charles Tarrant.
