Most gracious Sovereign,

E your Majesty's most dutiful and loyal Subjects, the Assembly of the Province of North Carolina, take this first Opportunity of our Meeting in General Assembly, to beg Leave to approach your Royal Throne, with unseigned Congratulations on the Honourable Peace, which the Wisdom of your Majesty's Councils, and the Valour and Conduct of your Fleets and Armies, have procured to your Empire; a Peace, which we, your Majesty's American Subjects, feel with the highest Sensibility, as we are thereby fecured in the Enjoyment of our Religious Rights, Possessions, and Liberties, free from the alarming Incroachments of our ambitious and restless Enemies.

May the Sound of Faction be distipated; and, in its Stead, the Love and Veneration of a grateful People rendered truly happy by your Majesty's Pa-

ternal Goodness.

Permit us, Royal Sir, to affore you of our most grateful and inviolable Attachment to your Majesty's Person, House, and Government; and that we cordially thare in the general Joy, which the Birth of a Second Prince must give to all sincere Lovers of Li-

berty.

May your Majesty live, not only to form their tender Minds in every princely Virtue inherent in your Royal House, but long to set them an Example worthy of Imitation, diffusing Blessings to Mankind. And when your last Hour shall come, (which Heaven-long suspend) may there never be wanting a Descendant, endowed with all the amiable Qualities of the illustrious House of Hanover, to fill the British Throne to the latest Posterity.

Truly sensible of the depressed and indigent Circumstances of this Country, we deplore that it was not in our Power, during the Course of the late War, to contribute so largely as we otherwise would have done: But we most humbly hope, that when your Majesty is pleased to take into your Royal Consideration the necessious and unsettled Condition of your Subjects in this Province, you will be pleased to accept of our utmost though weak Endeavours to

evince our Duty and Loyalty.

That your Majesty may long reign in the Hearts of an united People, and happy in the Possession of your Royal Consort; That the British Church and Constitution may be enlarged, and its Commerce extended to the utmost Parts of the Globe, are the most ardent Withes and Prayers of your Majesty's humble, dutiful, and loyal Subjects of this Province.
