The Duke of Termoli returned last Friday from Vienna, whither he had been sent to pay a Compliment, in his Sicilian Majesty's Name, upon the Election and Coronation of the King of the Romans. This Nobleman has been presented on his Departure by the Empress Queen, with her Imperial Majesty's Picture richly set with Diamonds.

The Epidemical Fevers continue still to reign here, but not with the same violent Symptoms. The Measures taken by the Government to put a Stop to this Calamity, especially by the eresting several Hospitals in the Skirts of the City, have already proved very beneficial. The Number of Burials decreases daily.

Genoa, July 28. His Royal Highness the Duke of York arrived here this Morning in perfect Health.

His Royal Highness was complimented by the Government of Novi, at a small Distance from that Town. This Afternoon the Master of the Ceremonies waited on, and complimented his Royal Highness on his safe Arrival, and acquainted him, that the Republick had named Six Nobles, as a Deputation from the Republick; his Royal Highness returned his Thanks, and declined to accept of the Deputation.

Turin. July 28. On Saturday last the 21st Inflant, his Royal Highness the Duke of York received a friendly Visit from the Duke of Savoy, the Prince of Piedmont, and the Duke of Chablais; and the Day following his Royal Highness dined with his Sardinian Majesty. The same Night a magnificent Supper and a great Ball were given at the Palace

which his Royal Highness occupies; and two Days after, the Prince of Carignan, who was in the Country Fifteen Miles from Turin, came from thence to pay his Respects to his Royal Highness, whom he invited to dine with him at his beautiful Seat of Raconis; where he likewise asked a Number of the most conspicuous of the Ladies and Noblemen of this Court to come to a Dinner; a Concert, and a Ball, which altogether, made it a most compleat and agreeable Entertainment. Last Thursday his Royal Highness took Leave of the King of Sardinia, and the rest of the Royal Family, by all of whom he was fincerely regretted; and Yesterday early in the Morning, his Royal Highness lest Turin to go to Genoa.

Copenhagen, July 31. The King of Denmark is expected here To-day in his Way to Brentwick, the Seat of the Grand Marshal, where his Majesty proposes to stay some Days, according to his Custom every Year.

Vieuna, August 6. Count Bruce; who is sent by the Empress of Russia to compliment this Court on the Election of the King of the Romans, arrived here on Sunday last.

Hamburgh, August 6. On Saturday Evening the Duke of Mecklenbourg-Schwerin came here to pass some Days with the Dutchess; and all he Foreign Ministers here have been to make their Court to his Serene Highness.
