PRESENT,

The KING's most Excellent Majesty in Council. W HEREAS His Majesty was pleased, by His Royal Proclamation, bearing Date the 12th Day of October last, to order, permit, and authorize the Importation of Salted Beef, Salted Pork, Bacon, and Butter, from Ireland, into that Part of the Kingdom of Great Britain called England (pursuant to the Powers vested in His Majesty for that Purpose, during the present Recess, by an Act passed the last Session of Parliament) until and provided the same be landed in any of the Ports of that Part of the faid Kingdom of Great Britain called England, on or before the Thirty-first Day of this Instant December. - And whereas the Time thereby limitted for the Importation of the faid Salted Provisions is now near expiring; and it being judged expedient that the same should be continued for as long Time as His Majesty by the said Act is empowered to permit the same—His Majesty, with the Advice of His Privy Council, doth therefore Order, and it is hereby accordingly Ordered, that the Time limitted by the faid Proclamation, for the Importation of Salted Beef, Salted Pork, Bacon, and Butter, from Ireland, be prolonged and extended to the Ninth Day of
