HE Diet continues their Deliberations with the greatest Tranquility : They have confirmed all the Acts that have been made during the Interreign ; and are at prefent chiefly employed in arranging the Taxes which are to be levied on the different Orders of the Republick, and in taking Meafures to improve the Revenues, and to enfure the Inland Commerce.

Venice, December 14. According to the fresheft Advices which the Magistrates of Health have just received from Dalmatia, the Plague was foread into two more Villages, and an Hamlet, in the Territory of Knin, and into two Villages in the Diffrict of Sign; but nothing new had happened in the two Villages, where it was already, in the Territory of Knin.
