An Act for rendering more effectual an Act, made in the Twelfth Year of the Reign of Her late Majesty Queen Anne, intituled, An Act for providing a Publick Reward for such Person, or Persons, as shall discover the Longitude at Sea, with Regard to the making Experiments of Proposals made for Discovering the Longitude.

Berlin.

Yesterday the King of Berlin, March 9. Pruffia, accompanied by the Prince Royal, and young Prince Henry of Prussia, and the two Princes of Brunswick, arrived here from Potzdain. His Majesty, in his Way to the Palace, vilited the Manufactory of China. The same Afternoon arrived also the Reigning Prince of Anhalt Dessau; and in the Evening the Marriage of that Prince with the Princess Louisa Henrietta Wilhelmina, youngest Daughter to Margrave Henry the King of Prussia's Cousin, was declared at Court. This Day the Ceremony of Betrothing was performed. His Pruffian Majesty, the rest of the Royal Family, the Reigning Prince of Anhalt Dessau, and the Hereditary Prince of Courland, dined with the Queen of Prussia; and at Night Prince Ferdinand, the King's Brother, gives a grand Supper and Ball to the Royal Family. The King of Prussia had a numerous and splendid Levée in the Morning, and M. de Braniski, Envoy Extraordinary from the King of Poland, had his first Audience, when he delivered his Letters of Credence to his Prussian Majesty.

Dantzig, March 6. The King of Poland has been pleased to confirm all the former Privileges of this City. The Prussian Troops begin to draw off from these Territories.

Hamburgh, March 12. Count Raab, the Imperial Minister, returned here this Asternoon from Vienna.

Bonn, March 14. On Tuesday last M. d'Ammon, one of the Directors of the Circle of Westphalia, and the King of Prussia's Resident at Cologne, died at that Place.
