Several Persons concerned in the illegal Collection and Delivery of Letters and Packets, in various Parts of the Kingdom, have lately been prosecuted, and have paid the Penalties of Five Pounds for every separate Offence, and One Hundred Pounds for every Week such Practice hath been continued;
