Berlin, September 14. This Morning the King of Pruffia, attended by the Prince Royal, young Prince Henry of Pruffia, and the two Princes of Brunswick in this Service, arrived here in pertect Health from Silesia. His Pruffian Majesty found the Nobility and Gentry affectibled in the Drawing Room at the Palace; and amongst the rest his Brother-Prince Henry, who came to Berlin last Thursday from Rhinsberg, in order to pay his Court to his Maj sty.

A few Days ago Prince Ferdinand, the King of Pruffix's Bro her, let out from hence with the Princess his Consort, for Schwedt, where they intend to poss some Weeks.

Hambourg, September 17. The Magistrates of this City have issued a Decree, ordering all publick Entertainments to be suspended for a Month on account of the Death of the late

Emption; and a general Mourning has commenced upon the Occasion.
