Dresden, December 25. Last Monday being the Elector's Birth-day, who entered into his Sixteenth Year, there was a numerous Court in the Morning to compliment his Electoral Highness on the Occasion. At Night there was a Drawing-room for the Ladies; but the Electress did not appear, having been obliged, for these three Days past, to keep her Chamber on Account of a violent Cold attended with a Fever; but her Royal Highness was Yesterday much better.

Berlin, December 28. Two Days ago his Majesty, who is in perfect Health, went from hence on Horseback to Fridericksfelde, a Pleafure-House, distant one German Mile from hence, belonging to his Brother Prince Ferdinand, as Grand Master of the Order of St. John of Jerusalem; and his Majesty was pleased to express his Approbation of the Changes and Improvements his Royal Highness is making, as well with regard to the House as the Gardens.

Copenhagen, December 31. The King, who has for some Time past, been afflicted with a Dropfical Disorder, and which had increased so much as to make it necessary to undergo the Operation of a Puncture, the same was performed on Saturday Morning last, which relieved his Majesty but for a short Time. He was very restless and severish on Sunday Night, and the Symptoms were such as to give but little Hopes of his Recovery; on which Account publick Prayers have been offered in all the Churches in this City, and the City Militia have received their Ammunition, together with Orders to be in Readiness, in Case of the melancholy Event of his Death, to guard the City till the Regular Troops have sworn Fidelity to the Successor.

The near Prospect of losing, in the Meridian of Life, a Sovereign univerfally beloved for his great Humanity, creates such an Affliction to the Royal Family, and the Subjects in general, as may be more easily imagined than expressed.
