

Navy-Office, May 26, 1766.

The Principal Officers and Commissioners of His Majesty's Navy give Notice, that on Friday the 25th of July next, they will be ready to treat with Persons willing to supply His Majesty's Navy with such Quantity of Hemp of British Growth, as they can deliver in the present Year, the Years 1767, 1768, and 1769, not exceeding 500 Tons in the whole Time, at such of His Majesty's Yards as shall be agreed upon at the Time of Treating.
