THE following Address of the Governor and Council of the Province of Pennsylvania, and Counties of Newcastle, Kent, and Suffex on Delaware, has been presented to His Majesty by Thomas and Richard Penn, Esqrs. being introduced by the Earl of Shelburne, One of His Majesty's Principal Secretaries of State: Which Address His Majesty was pleased to receive very graciously.

To the King's most Excellent Majesty,
The Address of the Governor and Council of the Province of Pennsylvania, and Counties of Newcastle, Kent, and Suffex on Delaware.

WE your Majesty's Faithful Subjects, the Governor and Council of the Province and Counties aforesaid, with the most profound Submission, beg Leave to approach the Throne on an Occasion the most affecting and interesting to us and all your other American Subjects.

Permit us, Royal Sir, with Hearts overflowing with Gratitude, humbly to acknowledge the manifold Instances of your paternal Tenderness and Affection extended to your Subjects in this distant Part of your Empire; and, in a more especial Manner, to express our lively Sense of your Majesty's unbounded Goodness, and the disinterested Benevolence of your Parliament, in the late Repeal of the Act imposing certain Stamp Duties in your Colonies.

We rejoice in this Opportunity of declaring that your Majesty's Administration hath been distinguished by the strictest Regard to Justice and an unwearied Attention to the Welfare and Happiness of your People: But when we reflect on this last signal Instance of your Majesty's exalted Virtue, that you have been graciously pleased to hearken to the Cries of your Subjects, and to stretch forth your Royal Hand to their Relief, notwithstanding many of them (blinded by a misguided Zeal) have committed Acts injurious to your Government, we are impressed with the highest Reverence for your great Magnanimity and princely Condescension.

We trust that your Majesty cannot fail to receive the warmest Returns of Gratitude and Loyalty from all your Subjects.—For ourselves, we humbly beseech your Majesty to accept of our unfeigned Assurances, that our Hearts are firmly attached to your sacred Person and Government, our Affection to our Mother Country inviolable, and our Lives and Fortunes entirely devoted to your Majesty's Service.

The Address of the Representatives of the Freemen of the Province of Pennsylvania, in General Assembly met.

Most Gracious Sovereign,

WE your Majesty's dutiful, loyal, and faithful Subject, the Representatives of the Freemen of the Province of Pennsylvania, in General Assembly met, under a deep Sense of your Majesty's great Condescension and Justice, beg Leave to render to your Majesty our unfeigned Thanks for your most gracious Assent to the Act repealing the Law granting certain Stamp Duties in America. The Paternal Concern for the Welfare and Prosperity of all your Majesty's Subjects, however remote, which your Majesty has demonstrated on this very important Decision, cannot fail of fixing in the Hearts of the good People of this Province, the most inviolable Affection and Loyalty to your Royal Person and Government, and exciting in its sincerest Prayers for the long Continuance of your Majesty on the Throne of those extensive Dominions, whose Happiness and Glory have been the invariable Objects of your Care and Attention.

The Assurance which your Majesty has been graciously pleased to give us of your Approbation of the civil Behaviour of the Province of Pennsylvania amidst the troublous and distracting which have agitated the other Colonies, fills our Breasts with Sentiments of the most respectful Gratitude, and demands our warmest Thanks. This Instance of your Majesty's Condescension and Goodness must engage the People we represent, to continue to recommend themselves still further by their dutiful Behaviour, to your Royal Favour and Protection.

We humbly entreat your Majesty will further permit us to embrace this Opportunity of expressing the high Sense we entertain of the Justice and Tenderness of your Parliament, who, ready to hear and consider the Grievances of your Majesty's Subject, have, upon a just Representation of the unhappy Circumstances of your Colonies, manifested their good Dispositions and Lenity to us in our late distressed Situation.

Fully sensible how much the Happiness of your People depends on a perfect Harmony and Connection between Great Britain and her Colonies, we assure your Majesty, that no Care or Endeavours shall be wanting, on our Part, to promote and establish that Union of Affections and Interest, which is so essential to the Welfare of both, and to preserve that Loyalty and Affection to your Majesty's Person and Government,

ment, which we esteem to be one of their first and most important Duties.

To the King's most Excellent Majesty,

The humble Address of your Majesty's Council of the Province of the Massachusetts Bay.

Most Gracious Sovereign,

WE your Majesty's most dutiful and loyal Subjects, the Council of your Province of the Massachusetts Bay, beg Leave, with the most sincere and raised Sentiments of Duty, Loyalty, and Affection, to address your Majesty, ever sensible that your Majesty's Paternal Care is not confined to your Subjects of Great Britain, but is as extensive as your Dominions— With humble Gratitude we acknowledge your Majesty's Goodness as in the other numerous and signal Instances of it, so more especially in graciously hearkening to the repeated Supplications of your dutiful and loyal Subjects in this and other your Provinces and Colonies in America, by giving your Royal Assent to the Bill for repealing the Stamp-Act; an Act which, in its Operation, might have been productive of Consequences not only detrimental to the Commercial Interest of Great Britain, but also have involved this Province, and all your Colonies, in Misery and Ruin.

We esteem it our Happiness, that from true Magnanimity of Sentiment your Majesty and your Parliament are disposed to overlook certain Enormities perpetrated during the late Transactions in the Colonies, justly distinguishing the Complaints and dutiful Remonstrances of loyal Subjects, from the Violence and Outrage of a profligate Rabble, abhorred by all Ranks among us; and that from the kind and indulgent Disposition prevailing in your Majesty and that August Body, we are encouraged to hope, that the Trade and Interests of America will receive every Relief which the true State of its Circumstances demands or admits.

This Proof of Indulgence and Affection in your Majesty and Parliament demands our most grateful Acknowledgments, and is an additional Obligation upon your Council, and all other your Subjects in these your Dominions, to yield a due Submission to the legislative Authority of Great Britain, and in all suitable Ways to demonstrate our Regard for that Country from which we sprang, and by which we have been protected and cherished. We are sensible of our peculiar Happiness in being the Subjects of such a King, whose Solicitude and Care is to render all his Subjects happy. And we assure your Majesty we shall contribute all that in us lies within our Department, by our Example, and in every other Way, to cultivate the Principles of Duty and Loyalty to your Majesty, and of Reverence for your Parliament; --- (Principles which have ever happily prevailed, and we trust ever will prevail within this Province :) And that we will, to the utmost of our Power, make the Administration of your Representative over us easy and happy, and, like faithful Councillors, whenever required, give him our best Advice for your Majesty's Honour and Service, and the Good of this your loyal Province.

May it please your Majesty,
WE your Majesty's most dutiful and loyal Subjects, the Representatives of the Colony of New Jersey, in General Assembly met, humbly beg Leave to approach your Royal Person, and with the most unfeigned Gratitude, to thank your Majesty for your great Condescension and Goodness in giving your Assent to the Repeal of the Act granting certain Stamp-Duties in America.

It has been invariably the Principle of your Royal House, to govern your People according to the Constitution, and their Glory to rule over a Nation of Freemen.

Your faithful Americans have ever been free, and with the most unbounded Loyalty and Affection to your Majesty, and Respect and Veneration for the Parliament of their Mother Country, they were most sensibly affected when they saw a Law passed that endangered both their Liberty and Property.

Their Struggles on this Occasion (until their Case could be laid before your Majesty and the Parliament) however they may appear, or are represented, were not those of Rebellion or Disaffection, but those of Freemen, attached to your Majesty's Person and Government.

It is with the greatest Satisfaction that we see your Majesty, your present worthy Ministry, and your Parliament, penetrating the true Cause of our Uneasiness, and relieving us from the Burthen of an impolitic Law. The Wisdom and Justice of this Measure will henceforth, we doubt not, induce your American Subjects to place the greatest Confidence in your Majesty and the British Parliament, and be a sure Means of conciliating the Affections of the People of both Countries.

Permit us, most gracious Sovereign, at the same Time that we present our sincere and humble Thanks to your Majesty for the Repeal of this Law, to assure your Majesty, that as we have heretofore granted Aids to the Crown suitable to our Circumstances; so whenever Requisitions are made for that Purpose, in the ancient and accustomed Manner, our Duty to your Majesty, and Concern for the Glory and Interest of Britain, will ever induce us cheerfully to comply therewith to the utmost of our Abilities. And as no Danger can approach Britain without giving us the most sensible Alarm; so your Majesty may be assured, that with filial Duty we shall ever be ready to afford all the Assistance in our Power, and stand or fall with that Kingdom from which we boast our Descent, and to which we are attached by the strongest Ties of Duty, Gratitude, and Affection.

Assenting to the Repeal of the late American Stamp-Act.

As the Distress and Anxiety which lately depressed the Minds of your faithful Subjects in these your Dominions, and excited the most alarming and melancholy Apprehensions, are now happily dissipated, the Joy we feel on this Occasion is not to be equalled but by the Sincerity of our Thankfulness and Gratitude for this signal Relief afforded us, and for the pleasing Prospect of such Extension of Commercial Privileges to Great-Britain and her Colonies, as must lay the Foundation of lasting Union between them and every Part of your Majesty's extensive Empire.—The Colonies thus cherished and protected, will, we trust, for Ages continue the happy Seats of Wealth, Freedom, and Loyalty.—Such Marks of Royal Favour, and Attention to the Welfare and Prosperity of a growing People, are worthy a Prince deservedly the Delight of his Subject: worthy the Wisdom and Dignity of a British Senate, the Constitutional Guardians of the Laws, the Liberties, and the Properties of the People.

Permit us to assure your Majesty, that we acknowledge the Wisdom, Justice, and Goodness of the Parliament of Great-Britain: That their Dignity and Authority ought ever to be supported; a Constitutional Dependence maintained; and a ready Obedience paid by all the Subjects of your Majesty's extensive Dominions; convinced by the present Motives of our Joy and Thankfulness, that whilst enlarged Views for the Commercial Concerns of your Kingdoms and Colonies, shall prevail in your Majesty's Councils, the British Parliament will be a Source of Laws adapted to the Genius of the Inhabitants of the Colonies, productive of every Advantage to be wished or hoped for, and firmly unite the most grateful and obedient Subjects to the most indulgent and amiable Sovereign.

Madrid, July 21. The Body of the late Queen Mother was conveyed, in great Pomp, to St. Ildephonso, and interred there on the 17th. It was attended by her whole Household; the principal Persons of which had afterwards the Honour of kissing his Catholick Majesty's Hand at the Escorial, upon his declaring that the Salaries should be continued to all of them during Life. The Obsequies of the Queen-Mother will last nine Days; after which the whole Court will remove to St. Ildephonso.

Turin, July 26. On the 23d Instant the Hereditary Prince of Brunswick arrived here in perfect Health.

Notwithstanding his Serene Highness wished to maintain a private Character, it was impossible to avoid his being received at Chambery and at Suze, (the two chief Towns through which he passed) with the Marks of Respect and Distinction he so justly merits. His Serene Highness was, the Morning after his Arrival here, conducted to Court by the Master of the Ceremonies, in two of his Sardinian Majesty's Coaches, and was most graciously received by the King of Sardinia, the Duke and Duchess of Savoy, and the rest of the Royal Family; and was afterwards reconducted back in the same Coaches.
