**W**Hereas His Majesty hath signified unto us His Royal Pleasure, That the Parliament of this Kingdom, which now stands Prorogued to the Thirtieth Day of this Instant August, be further Prorogued to the Twenty-first Day of April next, 1767: We do therefore Publish and Declare, That the said Parliament be, and accordingly the said Parliament is hereby further Prorogued to the Twenty-first Day of April next; whereof the Lords Spiritual and Temporal, and the Commons in this present Parliament, are to take Notice accordingly.

GOD Save the KING.

*Saltoff, in the Province of Belgorod, June 3, O. S.* Yesterday happened here a most violent Storm of Thunder and Lightening, Wind and Rain, which has done incredible Damage, and entirely destroyed all Hopes of a tolerable Harvest for this Year. There fell, at the same Time, a prodigious Quantity of Hail-Stones, of a square Form, and larger in Size than a common Walnut; and, what is very remarkable, though the Weather was extremely hot, they lay on the Ground above a Quarter of an Hour before they melted.

*Peterhoff, July 18, O. S.* On Sunday last Father Plato, one of her Majesty's Chaplains, and Præceptor in Theology to his Imperial Highness the Grand Duke, was consecrated, in the Court Chapel, Archimandrite of the Monastery of the most Holy and Undivided Trinity, commonly called the Tröitzkoi. The Ceremony of Consecration was performed by the Metropolitan of Novogrod.

The new Archimandrite then preached a most incomparable Sermon, at which the Knipress expressed the highest Satisfaction; and did him the Honor of inviting him to dine at the Imperial Table.

*Turin, August 20.* His Serene Highness the Hereditary Prince of Brunswick arrived in Town last Sunday, about Four o'Clock in the Afternoon, in perfect Health, from his Journey in the Alps; and seems extremely well pleased and satisfied with the King of Sardinia's great Attention to have him provided with every Thing necessary to make his Excursion agreeable. On Monday his Serene Highness paid his Court to all the Royal Family, and had a most gracious Reception. Yesterday he dined at his Excellency Count de Viry's; and this Day with the King and the Royal Family. His Serene Highness proposes leaving this Place next Saturday, and to take Alexandria, Casal, Tortona, and Pavia, in his Way to Milan, where he proposes staying two or three Days, and then to pursue his Travels to Venice by the Way of Parma, Plazencia, Bologna, and Padua, and hopes to be at Venice the 18th or 19th of next Month.
