

In an Hour after their Arrival all the Nobility in Town went to pay their Court to them; and an Express having been sent to his Royal Highness Prince Charles, informing him of their Arrival, he immediately came to Town, and went directly to the Play House to meet them, and expressed the greatest Joy and Pleasure in having the Honour of seeing them at Brussels.

In the Evening his Royal Highness the Duke of York arrived here under the Title of Earl of Ulster, and went to the Comedy, where he was received by Prince Charles with all the Marks of Love and Affection.

Dublin, July 10, 1767.

Whereas a Light-House hath for some Time past been building at the East End of the Piles on the Larboard Hand of the Entrance of the Harbour of Dublin; This is to give Notice to all Masters and Commanders of Ships, that there will be a Light thereon in an Octagon Lanthorn of Sixteen Feet Diameter, on the Night of the 29th Day of September next, and every Night afterwards, instead of the old floating Light, which will be discontinued. The new Light-House is about 36 Fathoms to the Southward of the Moorings of the old floating Light, and is particularly described in the new Chart published by Scale and Richards, which Chart was executed under the Inspection of the Pilot Committee, and is the only accurate Chart yet published of the Harbour of Dublin.
