in Ireland; the Person so convicted shall, for every Artificer contracted with, or seduced, forfeit FIVE HUNDRED POUNDS, and shall fuffer Imprisonment in the common Gaol of the Country or Stewartry wherein fuch Offender shall be convicted, for Twelve Calendar Months, and until Forfeiture be paid: And in Case of a subfequent Offence of the fame Kind, the Persons so again offending shall forseit, for every Person contracted with or seduced, ONE THOU-SAND POUNDS, and shall suffer Imprisonment in the common Gaol of the County or Stewartry wherein such Offender shall be convicted, for Two Years, and until such Forseiture be paid.

If any Person in Great Britain or Ireland shall put on Board any Ship or Boat not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utenfils as are commonly used in, or proper for the Preparing, Working up or Finishing of the Woollen or Silk Manufactures, or any Part of such Tools, he shall for every Offence forfeit all fuch Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Seffion in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, and for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as fuch Officer shall find on Board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools so feized shall, after Condemnation, be publickly fold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Meiety to the Officer who shall seize and secure the same.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on Board his Vessel, he shall for every such Offence forseit ONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Persons exporting the Tools; and if the Vessel belongs to His Majesty, the Captain shall not only forfeit ONE HUNDRED POUNDS, but shall also forseit his Employment, and be incapable of any Employment under His Majesty.

If any Officer of the Customs in Great Britain, or of the Revenue in Ireland, take, or knowingly fuffer to be taken, any Entry out-ward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the faid Tools, or knowingly suffer the same to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also forseit his be delivered to the Board before One o'Clock on the Office, and be incapable of any Office under faid 18th of January next. His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the
