Stockholm, June 3.

HE King of Sweden was in Danger of being killed by a Fall last Tuesday. His Majesty, driving the Queen and the Princess Sophia Albertina in a four-wheeled Chaife, a sudden Jolt threw him out of the Box, and not being able to disengage himself entirely, he was dragged about twenty Yards before the Servant behind could get forward to stop the Horses: His Majesty received some Bruises, but being blooded immediately, there is Reason to hope this Accident will have no ill Confequences.

Some new Ordonnan-Copenhagen, June 7. ces have lately been issued here, by which a Tax is laid upon all Employments, whether Eccle-fiastical, Civil, or Military, of 2 per Cent. as well upon the Perquifites and Emoluments arifing from them, as upon the fixed Salaries annexed to them: This Tax is to continue but for two Years, and those who are subject to it are to be exempted from that of the Capitation. is to take place the first of next July.

Another, of one Quarter per Cent. of the real Value of all Lands, Houses, or Mortgages, is to be paid. The Terms for the Payment of this are to be on the 11th of June and December; but that of its Duration is not fixed.

The Duty upon imported Salt is almost entirely taken off; what has hitherto paid 15 Rix Dollars per Last, containing 18 Tons, is now reduc'd to 4 Schilling (a 40th Part) per Ton; in the Place of which a Tax of 4 Schilling upon each Person above the Age of 12 Years is to be levied. The Permission of importing, upon their own Account, is allow'd to whoever is inclined to do fo.
