**T**HIS Day the most Reverend Father in God Frederick Lord Archbishop of Canterbury, was, by His Majesty's Command, sworn of His Majesty's most Honourable Privy Council, and took his Place at the Board accordingly.

*Petersbourg, September 9.* The Empress has been at Sarskoezelo, where the Marriage of Count Wolodimir Orlow, (a younger Brother of the Chambellan) with the Countess of Stakelberg, was celebrated; and her Imperial Majesty returned on Tuesday last.

*Vienna, September 21.* We have the Pleasure to learn, that the Inoculation of the Archduchess Therese, and the Archdukes Ferdinand and Maximilian, succeeds perfectly well. The Small-Pox is of the most favourable Kind, and so slight, that though this is the Fourth Day of the Eruption, they walked this Morning in the Garden of Schonbrun.

*Drifden, September 28.* Sunday Morning last Te Deum was sung for the Accession of his Electoral Highness, and at Court there was a most splendid Gala.

*Hague, October 4.* This is the Anniversary of the Prince of Orange's Marriage; and Prince Lewis entertains the Prince and Princess, and the whole Town, this Evening.

Navy-Office, September 26, 1768.

The Right Honourable the Lords Commissioners of His Majesty's Treasury having appointed Money for paying Half-Pay to Sea Officers, from the 1st of January to the 30th of June, 1768, according to His Majesty's Establishment on that Behalf; These are to give Notice, that the said Payment will begin to be made at the Office of the Treasurer of the Navy in Broad-Street, on Monday and Tuesday the 17th and 18th of October next, at Ten o'Clock in the Morning; viz. they are to be paid their Half-Pay; but also produce Certificates that they have subscribed to the Test, and taken the Oaths required by Act of Parliament to His present Majesty; and in Case any of the said Sea Officers shall not be able to attend themselves to receive their Money, but employ Attorneys for that Purpose, that the said Attorneys may produce the like Certificates and Affidavits from the Persons they are employed by.

**PUBLIC NOTICE** is hereby given, that the several Mails for America, upon this New Arrangement, are to be made up at this Office on Wednesday the 5th of October next, and will continue to be dispatched from hence in the same Manner upon the first Wednesday in every Month.

The Mail for New York will contain the Letters for all the Provinces on the Continent of America, from Virginia Northwards. That for Charles Town will include the Letters for North and South Carolina, Georgia, and East Florida. The Letters for Pensacola and all Parts of West Florida will be forwarded from Jamaica by every Opportunity. The Mail for the West Indies will contain the Letters for Barbadoes, all the Leeward Islands, and Jamaica, from whence the Packet-Boats are, instead of proceeding to Pensacola, to return immediately to Falmouth.
