According to the Pope's Declaration, the Ceremony of his taking Pollefion is to be performed on the 26th Inflant, in the same Manner as it was practised by his Predereffors, excepting that no Titles are to be inferted in the afeal Arch to be erected by the Court of Naples for that Purpose.

lick Audience of the Pope.

The Cavalcade, which is to be made on the 26th Inflant, is to begin from the Quirinal, and not from the Vatican as usual; by which an Expence of about 10,000 Crowns will be faved.

Florence, November 28. On the 24th the Anniversary of the Great Dutchess's Birth-Day, who has compleated 24 Years of Age, was celebrated here, though the Court refides at Pifa; the Nobility and Mility Officers in Gala were admitted to kits the young Archduke's Hand, and in the Evening there were the usual Fireworks, and the Discharge of the Artillery of the Castles.

Yesterday, the Anni-Stockbolm, November 28. verlary Chapter of the King's Orders was held as usual, and his Majesty gave the two vacant Blue Ribbons to the Senators Count Bielke and Stockenfrom: The Commanderies of the North Star were given to the two Senators Walwick and Beckfries, to Count Barck, the Swedish Minister at Vienna, and to M. Adlercrants, Intendant of the Court.

The Commanderies of the Order of the Sword were given to the two Senators, Count Barck and Snoilski, and to two Major-Generals, Scheffer and Ramfay.
