The KING's most Excellent Majesty in Council. THEREAS by an Act of Parliament paffed in the 26th Year of His late Majesty's Reign, entituled, "An Act to oblige Ships more effectually to per-" form their Quarantine, and for the better prevent-"ing the Plague being brought from foreign Parts into Great Britain or Ireland, or the Isles of Guernsey, Jersey, Alderney, Sark, or Man," It is among many other Things enacted, That all Ships and Vessels arriving, and all Persons, Goods and Merchandizes whatsoever, coming or imported into any Port or Place within Great Britain or Ireland, or any of the Isles aforementioned, from any Place or any of the Isles aforementioned, from any Place from whence His Majesty, His Heirs or Successors, by and with the Advice of His or their Privy Coun-cil shall judge it probable that the Infection may be brought, shall be obliged to make their Quarantine, in such Place and Places, for such Time, and in such Manner as has been, or shall, from Time to Time, be directed, by His Majesty, His Heirs or Successors, by His or their Order or Orders, made in His or their Privy Council, and notified by Proclamation, or published in the London Gazette; and that until fuch Ships, Vessels, Persons, Goods and Merchandizes, shall have respectively performed and be discharged from such Quarantine, no such Perfon, Goods or Merchandizes, or any of them, shall come or be brought on Shore, or go or be put on Board any other Ship or Veffel, in any Place within His Majesty's Dominions, unless in such Manner, and in such Cases, and by such Licence, as shall be directed or permitted by such Order or Orders made by His Majesty, His Heirs or Successors, in Council as aforesaid; and that all such Ships and Vessels, and the Persons or Goods coming or imported in, or going or being put on Board the same; and all Ships, Vessels, Boats and Persons receiving any Goods or Persons out of the same, shall be subject to such Orders. Pulse and Discourse to fuch Orders, Rules and Directions concerning Quarantine and the Prevention of Infection as have been, or shall be made by His Majesty, His Heirs and Successors, in Council, and notified by Proclamation, or published in the London Gazette as aforementioned, under such Pains and Penalties as are inflicted by the faid Act.

And whereas Information hath been received, that the Plague hath broken out, and now rages in Wallachia, Podolia, and other Parts of Poland, and His Majefty, by and with the Advice of His Privy Council, doth thereupon judge it probable, that the Infection may be brought into this Kingdom, from Dantzick, or some other Port or Place in Royal and Duset Pruffia, or Pomerania; His Majetty doth therefore, by and with the Advice of His Privy Council, hereby order, that all Ships, Veffels, Perfons, Goods and Merchandizes, now arrived, or that shall hereafter arrive, in any Port of this Kingdom, or the Isles of Jersey, Guernsey, Alderney, Sark, or Man, from Dantzick, or any other Port or Place in Royal and Ducal Prussia, or Pomerania, do make their Quarantine for Forty Days, which is to commence and he communed from the Day each Ship commence and be computed from the Day each Ship or Veffel shall come to Anchor, in the Place ap-

That the Place for performing Quarantine by such Ships and Vessels (not having the Insection on Board) as are bound to the Rivers of Thames and Medway. be Standgate Creek; and by fuch as are bound to any other of the Ports of Great Britain, be fuch Places as shall be appointed by the Officers of His Majesty's Customs in the said Ports, who are hereby impowered and required to appoint proper Places for the fame: And that the Places for performing Quarantine, within any Port of the faid Isles of Jersey, Guernsey, Alderney, Sark or Man, be such Places as shall be appointed by the respective Governors of the faid respective Isles, who are hereby impowered and required to appoint proper Places for the fame

That no Pilot shall go on Board any Ship or Veffel obliged to perform Quarantine, in order to conduct the same into any Port or Place, but shall perform such Service in some other Boat or Vessel; which Boat or Veffel shall keep as much to the Windward of the Ship or Veffel so to be conducted as possible: And if any Pilot or other Person shall go on Board fuch Ship or Vessel, such Pilot or other Person shall persorm Quarantine in like Manner as any Person coming in such Ship or Vessel shall be

obliged to perform the fame. That all Goods, Wares, and Merchandizes, liable to Quarantine as aforefaid, shall be opened, unpacked, and aired, unless His Majesty shall think fit, by His Order in Council, to direct other Ways, and fo remain a Week; other than Hemp and Fiax, Paper or Books, Silk Raw, Thrown, or Wrought, Linnen, Cotton Wool, Cotton Yarn, or Manufactured, Wool Raw, or any wife Wrought, Feathers, Gro-grain, or Mohair Yarn, Human Hair, Goats Hair, Carmenia Wool, Carpets, Camblets, Burdetts, or other Manufactures of Silk and Cotton, Kid Skins, and Skins in the Wool or Hair, Spunges, Wine and Oil in Chefts, Thread Stockings, all Goods packed with Straw or Cotton, Straw Hats and Brushes, Matting and Artificial Flowers; which Goods and Merchandizes, so as aforesaid enumerated, are to be opened, unpacked, and aired, unless His Majesty shall think fit, by His Order in Council, to direct otherwise, and so remain for the Space of a Fort-

That all Goods imported by fuch Ships and Veffels as are bound for the Rivers of Thames and Medway, be aired on Board a Floating Lazarette, which is appointed for that Service in Standgate Creek; and that the Places for airing Goods that shall be imported in Ships bound to any other Ports of Great Britain, be such as shall be appointed by the Officers of His Majesty's Customs; and that the Places for airing the Goods imported into any of the faid Isles of Guernsey, Jersey, Alderney, Sark or Man, be such Places as shall be appointed by the Governors or Commanders in Chief of the faid respective Isles, upon the Spot, who are hereby impowered and required to appoint proper Places for the fame.

That whatfoever Ship or Person shall receive any Men or Goods from on Board any Ship or Vessel under Quarantine, shall be compelled to perform the like Quarantine.

That fuch Persons as, after Quarantine personed, shall be employed in the Hold of any such Ship or Vessel, for the taking any Goods, not liable to retain Insection, from the Goods
