to give all due Encouragement to all fuch Landmen, who shall voluntarily enter themselves in Our Service; We have thought sit, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation; and We do hereby promise and declare, That all such Able-Bodied Landmen, not above the Age of Thirty-five Years, nor under the Age of Twenty Years, fit for Our Service, who shall, on or before the Thirty-first Day of December next, voluntarily enter themselves to serve on Board Our Royal Navy, either with the Captains or Lieuce-nants of Our Ships, or the Chief Officers on Board fuch Tenders as thall be employed for raising Men for the Service of Our Navy, shall receive, as Our Royal Bounty, the Sum of Twenty Shillings each Man; such Sum to be paid them by the respective Clerks of the Cheque reliding at the Ports or Places where the Ships, into which they half be entered, shall be, immediately after the Third Master of such Men. And for Prevent on of any Abares by any Persons leaving the Vessels to which they shall belong, and entering themselves on Board any other Ships or Vessels in order to obtain the said Bounty-Money; We do hereby declare and command, That fuch Men, belonging to any of Our Ships or Vef-fels, as shall absent themselves from any of the faid Ships or Vessels to which they shall belong, and shall enter themselves on Board any other of Our fail Ships or Veffels in order to obtain the faid Bounty, shall not only lose the Wages due to them in the Ships or Vessels they shall leave, but also be feverely punished according to their Demerits.
