Florence, December 1.

ON the 22d past their Royal Highnesses the Great Duke and Duchess arrived from Vienna.

Dresden, December 9. The Pregnancy of the Electress having been declared at Court, Prayers on that Occasion are to begin this Day in all the Churches of the Electorate,

Hague, December 21. On Wednesday last, being the Day appointed for Christening the new-born Daughter of their Serene and Royal Highnesses the Prince and Princess of Orange, that Ceremony was performed, with the greatest Solemnity, in the Great Church of this Town. The States-General, as well as several of the Provinces and Towns of the Republick, by their Deputies, attended the Prince- Stadholder, in Procession, to the Church, and returned from thence, in the same Manner, after the Baptism was administered. The young Princess was named Frederica, Louisa, Wilhelmina; and had the Honor to have the King of Great-Britain, the King of Prussia, and their High Mightinesses, among her Sponsors. The Garrison was under Arms, and the Companies of Burghers lined the Streets through which the Procession passed, and the Church was magnificently decorated. The Prince of Orange entertained the numerous Company in a friendly Manner at Dinner, after the Ceremony; ever, at the Palace called the Old Court, which was illuminated in the Evening, but the Town was pot, by his Serene Highness, upon account of the Deceas & Provisions, had signified his Wishes, to the States, that the Inhabitants might be excused from such expensive Demonstrations of their Affection; expressing his Desire that the publick Joy, upon this Event, might rather be testified by Marks of Liberality towards the Poor; the Collections for whom, in the Churches, have been very considerable upon this Occasion.

Yeesterday; and this Day, Deputations from the States-General, and the different Provinces and Towns, have had the Honor to wait upon the Prince of Orange, and accompanied their Compliments of Congratulation, with the free Gifts of their Constituents, to the new-born Prince, which amount to upwards of Thirty-five Thousand Florins yearly for her Life.
