

Count *Starenberg* attacked, and after a long dispute gained them, and lodged his Men in them, though not without very considerable loss on both sides.

From the Camp before *Philipsburg*, July 22. The 19 instant Count *Starenberg* began to batter the Town from his Battery; and the same night he attacked, and after a sharp dispute, gained a small Fort or Redoubt which is before the Count's camp; we had on our side about 100 killed and wounded; and in the said Fort we found 85 of the French killed; so that the Siege advances very well, though we are afraid, that the overflowings of the *Rhine*, which begins to rise very much, will extremely incommode us. Yesterday the Imperial Army under the command of the Duke of *Lorraine*, came to *Heiligenheim*, within half a League from hence, and at present lies posted between *Spire* and *Germesheim*; from whence it will not stir till this place be taken. In the meantime, the Duke of *Lorraine* fortifies his Camp.

From the French Camp at *Selz*, in *Alsace*, July 23. We have been encamped here these two days, within five hours march from the Imperial Army, which lies posted between *Germesheim* and *Spire*, where they have two Brigades over the *Rhine*. We do not yet know when we shall remove from hence. From *Philipsburg* we hear, that the Besiegers rock the 19 at night, small Work or Fort, which lay before the Count's camp, and kept it, though with considerable loss on their side.

*Cologne*, July 24. The *Heer Vander Eeck*, Envoy from the Prince of *Orange*, who came to demand of the Duke of *Newburgs* Ministers a farther supply of Men, is returned to the Camp before *Maastricht*. From *Francfort* we hear, that General *Fermuller* was returned to the Army, which it was expected would be very suddenly engaged in a Battel with the French.

From the Camp before *Maastricht*, July 25. The 23 instant two of our Batteries began to play, the one of twelve pieces of Cannon, and the other of five; on the 23 we had a third Battery of eight pieces, and the 24, a fourth of six pieces, all of them carrying 24 lb. Bullet; and this day we have planted six whole Cannon, and three Culverins, with which we continually batter the Town from morning till night; but in the night the Besieged still repair the ruines our Cannon makes. They fire likewise very furiously upon us, and do great execution. The last night we advanced our Approaches so near to one of their Batteries or Redoubts, that it is believed we shall suddenly attack it. The Besieged have not since the Siege made any Sally, of which we know not the meaning. The *Rhine* grows is slightly wounded in the Cheek; and this day his Highness, who is constantly twice a day in the Trenches, received likewise a slight wound in the Arm. We hear as yet nothing of the Bishop of *Munster* Troops, who, it was said, were to come to this Siege.

*Amsterdam*, July 28. One of our Men of War is arrived from *Graveling*, from whence are come in her the Count *Oxenfurze*, and another Senator of *Sunderland*, who are going to *Nimwegen* in quality of Ambassadors from that Crown. The Captain of the said Man of War tells us, That the *Sieur Guldenlicu* was come with his Army within three Leagues of *Gorinburg*. We have Letters from *Mosco* of the 23 past, which say, That the Ambassador of this State was parted thence on his return home. That on the 19 of that Month a Fire happened in that City, which burnt several houses, and what is most to be lamented, that above 300 People were burnt or killed by other accidents. That on the 22, happened another Fire more violent than the other, burning down above 4000 houses, and destroying a great many People; so that by those frequent Fires that have hapned there of late, above half that City lies in Ashes.

*Hague*, July 28. The States of *Holland* are still assembled, but intend to separate about the middle of the next Week. We do not hear that a final resolution is as yet taken concerning the Equipping the Men of War designed for the *Mediterranean*. The Siege of *Munster* advances very well, the last Letters we have from thence are of the 25 instant, they give us an account, That in the Princes quarter were several Batteries, on which were planted 40 pieces of Cannon; which battered the Town very furiously, and had ruined two Batteries, and done other considerable execution; That the Besieged were not wanting likewise to make use of their Cannon, with great effect; That the 24, the Trenches were advanced within Pistol shot of an Out-Battion, there having been that night about 30 killed; That they were running several Lines, to discover the Mines of the Besieged; And that in a day or two, it was believed some of the Outworks would be stormed; That the 25, his Highness,

as he was coming out of the Trenches, whither he had led his own Regiment of Guards, received a Musket shot in the right Arm, which passing only through the fleshy part without touching the Bone, made a wound of little consideration, and did not hinder him from being on Horseback most part of that day. The *Rhine* grows is likewise wounded in the Cheek, but very lightly. The Major of Colonel *Fennel's* Regiment, who was said in our last to have been killed, is still alive, but very dangerously wounded. Our Letters from *Ormanau* tell us, that the Siege of *Philipsburg* begins to grow very warm; That the 19, at night, Count *Starenberg* attacked the Contra Approaches made by the Besieged, and gained them; but that to recover them, the French had made two great Sallies, and in the last obliged the Besiegers, who being reinforced, recovered those Posts again, and kept them; in which disputes, about 3 or 400 men are said to have been killed on both sides.

*Paris*, July 29. We are in hourly expectation to hear that a Battle has been fought between our Army and that of the Emperor in *Alsace*; the last Letters from those parts having them very near together, and the Duke of *Luxemburg* resolved to endeavor the relief of *Philipsburg* without any farther loss of time, and the rather, because that Siege begins to be pressed very closely. We have not since our last, any particular account of what passes at the Siege of *Alce*, though in general, it is said, that it advances very well, and that the Besieged cannot hold out long, though in the mean time, the Besieged defend themselves very well. It is said that since the place was invested, 200 Men got into it from *St Omers*, or some other Spanish Garrison in that quarter. There be those that still discourse of the Prince of *Condé's* going for *Flanders*, to command the Kings Army there; but without any certainty. We expect every day to receive advice from *Thoulon* of the departure of our Fleet from thence, in order to its return to *Sicily*.
