Stockholm, August 14.
DVICE has been received from Stralfund, that the Queen Dowager and the Princess Sophia Albertina were expected there the 7th, in order to embark the 11th for Ysled; so that an Express is hourly expected with the News of her Majesty's Arrival.

In the Plenum of last Wednesday no Affair of Consequence was brought before the States; but it was resolved by two Orders, that several of the least necessary Committees should cease at the End of I next Week, in order that the Diet might more easily

be brought to a speedy Conclusion.

Stockholm, August 18. This Day the States were assembled in Pleno extraordinarily, when an Extract of the Secret Committee's Protocol was read, containing an Account, that the Garrison of Christianstadt in Schonen had revolted, and made itself Master of the Fortress, headed by one Hellichius, a Captain in the faid Garrison; and that, as this Affair may have dangerous Consequences, the Secret Committee has, for the better Security of this Capital, ordered one Batallion of the Regiment of Upland, and one of that of Sudermania, to march hither, and the Cavalry of the Burghers to patrole in the Night. Senator Funck and General Pecklin are also lent down to Schonen, impowered to asfemble the Troops, and take such Measures as shall be found necessary to reduce the revolted Garrison and restore the publick Tranquillity.

Several of the Members of the Secret Committee having absented themselves for a long Time, new ones have been elected in their Places; amongst which are General Pecklin, Count Dohna, Baron Gronhagen, Baron Bror Cederstrom, Lieutenant-

Colonels Peter Schonstrom and Vicken.

Stockholm, August 21. Yesterday Morning a Paper was laid upon the Table, in one of the Apartments of the Palace, for all those to subscribe, who are willing to swear Fidelity to the King; and it is said that the Number of Subscribers has

been very large.

Stockholm, August 22. Yesterday being the Day when the Form of Government, sworn to by the King, of the 29th of May, and by the States the 1st of June, was to be abolished, and a new one to be produced in a Plenum Plenorum of all the Orders, a large Detachment of Guards was ordered to take Possession of the Square where the House of Nobles stands; and the Palace was invested on all Sides with Troops, and Cannon were placed in the Court near the Hall where the States were affembled.

The Scene was opened by a Speech from the Throne: His Marchy had in his Hand the Silver Hammer of Gustavus Adolphus, with which he made the Signal for Silence, an Office usually performed by a Senator, but none were pre-fent. His Majesty concluded his Speech by affuring the Plenum, that he did not defire the Sovereignty, and would take a Solemn Oath to re-nounce it, which he immediately did.

His Majesty then ordered the new Form of Government to be read to them by a Secretary of Revision. This Piece consists of above Forty Arti-

cles; the essential ones are,
11t, The King is to chuse the Senate himself. 2dly, His Majesty is to call the States together when he pleases, and to separate them also when he pleases, after three Months. 3dly, The Contributions are to be given by the States; but if not granted within Three Months, the old ones are to remain: In Case of Invasion, or pressing Necessity, his Majetty may impose some Taxes for raising Money till the States can be assembled.

4thly, When the States are affembled, they are to deliberate upon nothing but what his Majesty

pleases to lay before them.

5thly, His Majesty has the sole Disposition of the Army, Navy, and Finances, and of all Employments

Civil and Military.

As foon as the whole of this Piece was read through, his Majesty asked the Plenum if they would give him their Qath to observe this Form of Government; which being answered in the Affirmative, he required them immediately to fivear to it, which they did accordingly. His Majesty then required the Speakers of the respective Orders to come to the Table and fign and feal the new Form.

After all this Ceremony was over, the King flood up and faid, that it was proper to thank Almighty God for his Assistance, in bringing about so happy an Event, and pulling a Psalm Book out of his Pocket, he began to fing the Te Deum, in which he

was accompanied by the Assembly

His Majesty then permitted the States to kifs his Hand, after which he left the Room, and the States feparated without knowing whether they were to meet again or not. This depends on his Majesty's Pleafure.
