HEREAS Our Parliament sands prorogued to Thursday the Fourteenth Day of this Instant September; We, with the Advice of Our Privy Council, do hereby publish and declare, That the said Parliament shall be further prorogued on the said Fourteenth Day of this Instant September, to Thursday the Twenty-sixth Day of October next: And We have given Order to Our Chancellor of Great Britain to prepare a Commission for proroguing the same accordingly. And We do hereby surther declare Our Royal Will and Pleasure, That the said Parliament shall, on the said Twenty-sixth Day of October next, be held for the Dispatch of divers weighty and important Affairs. And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs, of the House of Commons, are hereby required to give Attendance accordingly, at Westminster, on the said Twenty-sixth Day of October next.

Officers of the Ordnance, for His Majesty's Service, without Leave or Permission, in that Behalf first obwithout Leave or Permission in that Behalf first ob-tained from His Majesty, or His Privy Councils, and whereas there is great Reason to suspect, that great Fraud and Collusion have been and may be, practised in the Shipping and Exportation of Gun-powder, Arms, and Ammunition, under Licences which have been already granted;—His Majesty doth therefore, by and with the Advice, of His Privy Council, hereby revoke and make voisiliall and every Licence and Permission which have been hitherto granted for the Exportation or carrying hitherto granted for the Exportation or carrying Coasswife of Gunpowder, or any Sort of Arms or Ammunition; and doth hereby order, require, prohibit, and command, that, during the Space of Three Months from the Date of this His Majetty's. Order in Council, no Person or Persons whatsoever (except the Master-General, Lieutenant, General, or Principal Officers of the Ordnance, for His Majesty's Service) do presume, without Leave or Per-mission in that Behalf first obtained from His Majesty, or His Privy Council, to transport, into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder, or any Sort of Arms or Ammunition, or ship or lade any Gunpowder, on any Sort of Arms or Ammunition, on Board any Ship or Vessel, in one der to transporting the same into any Parts, beyond. the Seas, or carrying the same Coastwife, upon l'ain's of incurring and suffering the respective Forseitures and Penalties inflicted by an Act passed in the 29th. Year of His late Majesty's Reign, intituled, "An Act. " to impower His Majesty to prohibit the Exportation " of Salt-petre, and to inforce the Law for impowering His Majelly to prohibit the Exportation " of Gunpowder, or any Sort of Arms and Am. "munition; and also to impower. His Majesty to "restrain the carrying Coastwise of Salt petre; "Gunpowder, or any Sort of Arms or Ammus nition."
