Weil Gracious Sovereign, WE, your Majefty's dutiful Subjects, Aldermen, Com-mon-Councilmen, Freemen, and Inhabitants of the antient and loyal Town of Cambridge, beg Leave, with all Duty and Humility, to approach the Throne, at this important Crifis, on which we do not impertinently this important Crifis, on which we do not impertinently prefume to obtrude on your Majcfty our Opinions or Advice, though for It we have numerous and great Ex-amples to plead, but defire only, together with many other of your Majcfty's loyal Subjects, to express at this Time our fincere Attachment to your Majefty's Perfon and Government, our Confcioufnels of your Majefty's many Royal Virtues, our atter Detectation of all Rebel-lion, Treafon, and Faction, and our fleady Refolution to fupport your Majefty, to the utmost of our Power, against all your Enemies, whether open or concealed, both at Home and Abroad; and to affure your Majefty's that we place fuch intire Confidence in your Majeffy's known Wildom and Goodnefs, that we cannot enterknown Wildom and Goodneis, that we cannot enter-tain the leaft Doubt that fuch Meafures, either of Vigour. or Lenity, of Coercion or Indulgence, will be purlued, as are beft adapted to reduce your deluded Sub-jects in America, now in a State of Rebellion and Anar-chy, to a due Obedience to your Majeffy, and Submit-fion to the Legislature of Great Britain. Senfible of the Freedom of every Subject of Great Britain, and grateful for the Happinels we enjoy under your Majefty's aufpicious Government, we fee with In-dignation those infidious Arts, by which the American Colonies have been deluded into an unlawful and unjuit

But while we view with Abhorrence those feditious Individuals, who, from a violent and reftless Tempere or the Impulses of Ambition, have feduced their Brethren into Detailion we competitionate the unhappy People. into Rebellion, we compaffionate the unhappy People, who by partial or unjust Representations have been in-volved in Scenes of Distress.

We flatter ourfelves they have already become fentible of their Errors, and that they will gladly embrace the carlieft Opportunity of returning to their Daty and Allegiance.

Should they perverfely continue in Arms, however anxioully we may with for their Friendfhip, we mult entreat your Majefty to adopt fuch Measures as fhall. appear necessary to enforce a due Obedience to the Laws and Constitution of Great-Britain.

We beg Leave to affine your Majefty, that we shall readily contribute, with our Lives and Fortunes, to fup-prefs the Rebellion in your Colonies. To bring about to defireable an Event is one of the most ardent Wifnes of our Hearts, and is only fecondary to our Ambition to teftify on every Occasion our Duty and Attachment to your Majefty.
