HEREAS the Time limited by His Majesty's Order in Council of the 21st of February last, for prohibiting the Exporting out of this Kingdom, or Carrying Coastwife, Gunpowder, Salepetre, or any Sort of Arms or Ammunition, will expire on the 23d of this Instant May; and whereas it is judged expedient that the said Prohibition should be continued for some Time longer, except in those Cases where (for the Benesit and Advantage of Trade, and for the Use and Defence of Ships trading to Receive Parts, and of the Transferts and Vistual Foreign Parts, and of the Transports and Victualling Vessels employed in His Majesty's Service) His Majesty, by His several Orders in Council of the of November, 1775, and of the 5th and 19th of February last, has thought proper to permit and allow the Exportation of, and Carrying Coastwife, Gunpowder, Saltpetre, Arms and Ammunition, under certain Conditions and Restrictions mentioned in the said Orders - His Majesty doth therefore, by and with the Advice of His Privy Council, hereby order, require, prohibit, and command, That no Person or Persons whomsoever (except the Master-General, Lieutenant-General, or Principal Officers General, Lieutenant-General, or Principal Officers of the Ordnance, for His Majesty's Service) do, at any Time, during the Space of Three Months, to commence from the said 23d Day of this Instant May, presume to transport into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder, Saltpetre, or any Sort of Arms or Ammunition, or ship or lade any Gunpowder, or any Sort of Arms or Ammunition, on Board any Ship or Vessel, in order to transporting the same here. Ship or Vessel, in order to transporting the same be-yond the Seas, or carrying the same Coastwise, except in the Cases comprized within the aforementioned Orders in Council of the 13th and 27th of October, and the 6th and 22d of November, 1775, and of the 5th and 19th of February last, without Leave or Permission in that Behalf first obtained from His Majesty or His Privy Council, upon Pain of incurring and suffering the respective Forteitures Year of His late Majesly's Reign, entituled, "An "Act to impower His Majesly to prohibit the Ex"portation of Saltpetre, and to enforce the Law
"for empowering His Majesly to prohibit the Ex-46 portation of Gunpowder, or any Sort of Arms " and Ammunition; and also to impower His Ma-i jefty to restrain the Carrying Coasswife of Salt-" petre, Gunpowder, or any Sort of Arms or Am-"munition." - And the Lords Commissioners of His Majefty's Treasury, the Commissioners for Executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master General of the Ordnance, and His Majesty's Secretary at War, are to give the necessary Directions herein as to them may respectively appertain.
