The King's Most Excellent Majesty in Council.

HEREAS His Majefty was gracioufly pleafed, by His Royal Proclamation bearing Date the Twenty-fifth Day of October last, to promise and declare, That the Bounties of Five Pounds for every Able Seaman, and of Two Pounds Ten Shillings for every Ordinary Seaman, fit for His Majefy's Service, should be paid in the Manner thereby directed, to every fuch Able and Ordinary Seaman, not above the Age of Fifty, nor under the Age of Eighteen Years, who fhould, on or before the Thirty first of December then following, enter themfelves to ferve in His Majeity's Royal Navy, either with the Cap-tains or Lieutenants of His Majefty's Ships, or the Chief Officers on Board fuch Tenders, as should be employed for railing Men for the Service of the Royal Navy: And whereas His Majefty was like-wile pleafed, by His Royal Proclamation bearing Date the Eighth Day of November laft, to pro-mife and declare, That a Reward of Two Pounds for every Able, and Thirty Shillings for every Or-dinary Seaman, fhould be paid, in the Manner thereby directed, to any Perfon who fhould difcover any Seaman or Seamen who might fecrete them-felves, that fo fuch Scaman or Seamen should be taken for His Majefty's faid Service by any of His Majesty's Sea-Officers employed for raising Men, on or before the faid Thirty-first Day of this Instant December : And whereas the Time limited by the faid Proclamations for Payment of the faid Bounty and Rewards is near expiring; and it being judged expedient for His Majetty's Service, that the fa'd Bounties and Rewards should be continued to be paid for some Time longer, His Majesty, with the Advice of His Privy Council, doth therefore Order, and it is hereby accordingly ordered, That the Time limited for Payment of the faid Bounties and Rewards be prolonged and extended from the faid Thirty-first Day of this Instant December, to the Twenty-eighth Day of February next inclusive.-Whereof all Perfons concerned are to take Notice, and govern themtelves accordingly.
