The KING's Most Excellent Majesty in Council.

**W**HEREAS His Majesty was graciously pleased, by His Royal Proclamation, bearing Date the 25th Day of October 1776, to promise and declare, That the Bounties of Five Pounds for every Able Seaman, and of Two Pounds Ten Shillings for every Ordinary Seaman, fit for His Majesty's Service, should be paid in the Manner thereby directed, to every such Able and Ordinary Seaman, not above the Age of Fifty, nor under the Age of Eighteen Years, who should, on or before the 31st of December then following, enter themselves to serve in His Majesty's Royal Navy, either with the Captains or Lieutenants of His Majesty's Ships, or the Chief Officers on Board such Tenders as should be employed for raising Men for the Service of the Royal Navy: And whereas His Majesty was also pleased, by His Royal Proclamation, bearing Date the 8th Day of November, 1776, to promise and declare, That a Reward of Two Pounds for every Able, and Thirty Shillings for every Ordinary Seaman, should be paid in the Manner thereby directed, to any Person who should discover any Seaman or Seamen who might secrete themselves, that so such Seaman or Seamen should be taken for His Majesty's said Service, by any of His Majesty's Sea-Officers employed for raising Men, on or before the 31st Day of December, 1776: And whereas His Majesty was likewise pleased, by His Royal Proclamation, bearing Date the 15th Day of August 1777, to promise and declare, That every Able-bodied Landman, not above the Age of Thirty-five, nor under the Age of Twenty Years, who should voluntarily enter himself to serve on Board any of His Majesty's Ships, on or before the 31st Day of October then next, should receive, as of His Majesty's Royal Bounty, the Sum of Thirty Shillings each Man, to be paid in Manner thereby directed: And whereas the Time limited by the said Proclamations, for Payment of the said Bounties and Rewards, hath been prolonged and extended to the 28th Day of this instant February; and it being judged expedient for His Majesty's Service that the said Bounties and Rewards should be continued to be paid for some Time longer; His Majesty, with the Advice of His Privy-Council, doth therefore order, and it is hereby accordingly ordered, that the Time limited for Payment of the said Bounties and Rewards be prolonged and extended from the said 28th Day of this instant February to the 30th Day of April next, inclusive. — Whereof all Persons concerned are to take Notice, and govern themselves accordingly.

**W**HEREAS the Time limited by His Majesty's Order in Council of the 18th Day of November last, for prohibiting the Exporting out of this Kingdom, or carrying Coastwise, Gunpowder, Saltpetre, or any Sort of Arms or Ammunition, will expire on the 23d of this instant February: And whereas it is judged expedient that the said Prohibition should be continued for some Time longer, except in those Cases where (for the Benefit and Advantage of Trade, and for the Use and Defence of Ships trading to Foreign Parts, and of the Transports and Victualling Vessels employed in His Majesty's Service) His Majesty, by His several Orders in Council of the 13th and 27th of October, and of the 6th and 22d of November, 1775, of the 5th and 19th of February, and the 23d of August and 25th of September, 1776, of the 16th of April, the 13th of August, and the 3d and 10th of October, 1777, of the 19th of June, the 7th and 26th of August, and the 10th of September last, has thought proper to permit and allow the Exportation of, and carrying Coastwise, Gunpowder, Saltpetre, Arms and Ammunition, under certain Conditions and Restrictions mentioned in the said Orders: His Majesty doth therefore, by and with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Person or Persons whomsoever (except the Master-General, Lieutenant-General, or Principal Officers of the Ordnance, for His Majesty's Service) do, at any Time during the Space of Three Months, to commence from the said 23d Day of this instant February, presume to transport into any Parts out of this Kingdom, or carry Coastwise, any Gunpowder, Saltpetre, or any Sort of Arms or Ammunition, or ship or lade any Gunpowder, Saltpetre, or any Sort of Arms or Ammunition, on Board any Ship or Vessel, in order to transporting the same beyond the Seas, or carrying the same Coastwise, except in the Cases comprized within the aforementioned Orders in Council, without Leave or Permission in that Behalf first obtained from His Majesty or His Privy Council, upon Pain of incurring and suffering the respective Forfeitures and Penalties inflicted by an Act passed in the 29th Year of His late Majesty's Reign, entituled, "An Act to empower His Majesty to prohibit the Exportation of Saltpetre, and to enforce the Law for empowering His Majesty to prohibit the Exportation of Gunpowder, or any Sort of Arms and Ammunition; and also to empower

“His Majesty to restrain the carrying Coastwise  
“ of Saltpetre, Gunpowder, or any Sort of Arms  
“ or Ammunition.” — And the Lords Commis-  
sioners of His Majesty’s Treasury, the Commis-  
sioners for Executing the Office of Lord High Ad-  
miral of Great Britain, the Lord Warden of the  
Cinque Ports, the Master-General of the Ordnance,  
and His Majesty’s Secretary at War, are to give  
the necessary Directions herein; as to them may  
respectively appertain.

The King has been pleased to confer the Honour  
of the Most Honorable Order of the Bath on James  
Harris, Esq; His Majesty’s Envoy Extraordinary  
and Plenipotentiary at the Court of Petersburg.

This Day Morton Eden, Esq; late His Majesty’s  
Minister Plenipotentiary to the Elector of Bavaria,  
and Minister to the Diet of Ratisbon, had the Ho-  
nour to kiss the King’s Hand, upon being appointed  
His Majesty’s Envoy Extraordinary to the Court of  
Copenhagen.

*Madrid, February 1.* The Government of Arra-  
gon, vacant by the Death of the late Governor,  
who lost his Life in attending his Duty at the Fire  
which consumed the Theatre at Saragossa, is given  
to the Marques de Valle Santoro, Son to M. Squil-  
laci.

*Dresden, February 14.* On Friday last General  
Mollendorf was invested with the Order of the Black  
Eagle by Prince Henry of Prussia.

All the Movements in this Army are now at an  
End. The whole View was the Expedition against  
Brix, which was executed by General Mollendorf;  
but the Success was not so compleat as was expect-  
ed, General Teuffel having been stoppt in his Pas-  
sage into Bohemia by the Quantity of Snow that  
had fallen, by which Means their Plan of sur-  
prizing three Austrian Regiments did not succeed.  
However, they are all returned into Saxony with  
the Loss only of a Major and four Standards of  
the Regiment of Wunfch, that were taken at an  
Outpost by a small Party of Croats. The Ad-  
vantages the Prussians have gained on this Expedi-  
tion are 350 Men, and a few Officers, Prisoners,  
two Pieces of Cannon, and burning the Magazine  
at Brix. General Mollendorf is returned to his  
Command at Freyberg, and for the present every  
Thing is quiet on the Frontiers.

*Whereas it has been humbly represented to the King,  
that, about Six o’Clock in the Morning of the 2d  
of last Month, a dreadful Fire broke out in the Royal  
Hospital for Seamen at Greenwich, which extended  
itself with such Rapidity and raged with such Violence,  
that, before the same could be extinguished, the Chapel  
and Cupola, with several of the Wards in Queen Mary’s  
Building, were destroyed, and other considerable Da-  
mage done; and whereas it has been further represented  
to His Majesty, that, notwithstanding the most diligent  
Enquiries, it hath not yet appeared whether the said  
Fire was the Effect of Accident, or wilfully and mali-  
ciously occasioned by some Evil-disposed Person or Per-  
sons at present unknown: His Majesty, therefore, for  
the better discovering and bringing to Justice any Per-  
son or Persons who may have been concerned in wilfully  
and maliciously setting Fire to the said Hospital, as  
above-mentioned, is hereby pleased to promise His most  
gracious Pardon to any One of the said Offenders (ex-  
cept the Person or Persons who actually set Fire to the  
said Hospital) who shall discover his or her Accomplice  
or Accomplices in the said Offence, so that he, she, or  
they, may be apprehended and duly convicted thereof.*

Whereas it has been humbly represented to the King, that on Thursday the 21st Day of January last, about Eight of the Clock in the Evening, Two Guns loaded with Balls, Slugs, and large Shot, were discharged at the Room where John Harward, of Hayne in the Parish of Plymtree in the County of Devon, Esq; usually sits, as Fraigne aforesaid, which Balls, Slugs, and Shot, shattered the Windows, and some of them penetrated the Wainscot on the opposite Side of the said Room; and that on the 26th Day of the same Month of January, a Letter in the following Words was brought to the House of the said John Harward, at Hayne aforesaid, by the General Post, viz. (superfcribed) For John Harward, Esq; at Plymtree near Culumpton, Devon:

John Harward

Old Harward I will tell thee thou art an old Rogue and I am Sorry that I should lost my Labour the other Night, I was informed that thee received a Slight Wound but now I find to the Contrary therefore I would have thee take Care for the last Error will be worse than the first.

P. S. You old Turk you are no Christian, nor Englishman, Butt you are a Land Mare Maid half fool and half Rogue, take heed and dont Deceive thy Neighbour nor thy self for you are Deceived by your nasty beeches of Whores this from your Friends

And also that, about the 3d or 4th Day of this present Month of February, a Letter was brought to the Huse of Francis Rose Drewe, of Grainge in the Parish of Broadhembury in the said County of Devon, Esq; by the General Post, of which Letter the following is a Copy, viz.

(Superfcribed) For Frances Rose Drewe, Esq; at Broad Hembury-Grange, Devon:

London Jan. 1. 1779.

Drew thee art a Narrow Back, Lowfey, false, Little forswearing, Little Rogue I dont look upon thee no more than the Leaf of an Asp for he Whivers and is gone, and be ye no more in remembrance I would have thee remember the old Carey's Coach when he received a Brace of Balls I would have thee drop in thy Knees and give thanks to Powder for its Dampness I would have thee Live like a Gentleman not like a Land Mar Maid half fool and half Rogue as thou behaves thyself.

Which Letter appears to be written in the same Hand Writing as that to Mr. Harward.

His Majesty, for the better discovering and bringing to Justice the Person or Persons concerned in discharging the said Guns, or in writing or sending the said Letters, is hereby pleased to promise His most gracious Pardon to any one of them (except the Person or Persons who did actually discharge the said Guns, or write the said Letters) who shall discover his or her Accomplice or Accomplices therein, so that he, she or they may be apprehended and convicted thereof.
