And we feel great Pleasure in the Resection, that thereby the Union between both Kingdoms, which we are fully convinced is inseparable from their Interests, will be more strongly cemented; and that from thence weishall be the better enabled to indulge the ardent Defire which we must ever have to use our utmost En-deavours to maintain the Honour and Dignity of your Majesty's Crown, and to add to the Strength, Power, and Authority, of the British Empire.
