tificate or Certificates such Officer is required to give, and the Commissioners of the Customs to transmit to the Lords Commissioners of His Majesty's Treasury, in order to be laid before this Board: And His Majesty is likewise pleased to permit and allow the Exportation of Sheets of Copper of and under the Weight of Two Pounds and an Half to the Foot Superficial to any Parts beyond the Seas, to which the same may be lawfully exported (except to any of the Ports belonging to France or Spain.) upon Condition that no more than Ten Hundred Weight of such Copper shall be exported by any one Person or Partnership, and that the Quantity laden or put on Board any one Ship or Vessel, shall not exceed Three Tons in the whole; and also upon Condition that such Sheets of Copper shall be first inspected and examined by the Agent or Agents appointed or to be appointed by the Commissioners of His Majesty's Navy; and that a Certificate, under the Hand and Seal of fuch Agent of Agents shall be first had and obtained, setting forth, that such Sheets of Copper are of and under the Weight above described.—And the Right Honour able the Lords Commissioners of His Majesty's Treafury, the Lords Commissioners of the Admiralty, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein; as to them may respectively appertain.
