HEREAS, by His Majeffy's Or-der in Council of the 25th Day of October, 1776, an Embargo was laid upon all Ships and Veflels la-den or to be laden in the Ports of Great Britain with Black Cattle and Hogs, Beef, Pork, Butter and Cheefe, or any Sort of Provisions, (ex-cept Fish, Corn or Grain of any Kind, or Pulle,) which Embargo hath in many Respects been taken off under certain Restrictions : And whereas it is thought proper that the faid recited Order of the 25th Day of October, 1776, be no longer conti-nued; but nevertheles it is requisite for the Public Safety, in the present Critical Conjuncture of Affairs, to prevent the Exportation of Provisions: It is therefore hereby ordered by His Majesty in Council, that an Embargo be forthwith laid upon all Ships and Veffels laden or to be laden in the Ports of Great Britain with Black Cattle and Hogs, Beef, Pork, Butter and Cheefe, or any Sort of Provisions, (except Fish, Corn or Grain of any Kind, or Pulse,) and that the faid Embargo do continue and remain upon fuch Ships and Veffels till further Order; but it is His Majesty's Pleasure, that the faid Embargo fhall not extend to any Ships or Veffels carrying Provisions to any Town, Port or Place within the Colonies of New Hampfhire, Maffachufet's Bay, Rhode Ifland, Connec-ticut, New York, New Jerfey, Penfylvania, the Three Lower Counties on Delaware, Maryland, Virginia, North Carolina, South Carolina, and Georgia, in Pursuance of an Act made in the last Session of Parliament, intituled, "An Act to al-low the Exportation of Provisions, Goods, Wares and Merchandize, from Great Britain to certain Towns, Ports or Places in North America, which are or may be under the Protection of His Ma. jefty's Arms, and from fuch Towns, Ports or Places, to Great Britain and other Parts of His Majefly's Dominions;" and it is alfo His Majef-ty's Pleafure, that the faid Embargo fhall not extend to any Ships or Veffels carrying Provisions to any other of His Majesty's Colonies in North America, or to any of His Majefty's West India Islands, or to H s Majefty's Forts and Settlements on the Coaft of Africa, or the Island of Saint Helena; provided that the Merchant Exporter of fuch Provisions do make Oath, on the Entry thereof, of the due Defination of the fame to the Port for which they shall be fo entered and cleared out as aforefaid, and do give Security by Bond to the proper Officers of the Cultoms, at the Port at which fuch Veffel shall enter and clear out, with Two able and fufficient Sureties, (of whom the
