Our Royal Will and Pleasure to call a New Parliament: And do hereby further declare, that, with the Advice of Our Privy Council, We have, this Day, given Order to Our Chancellor of Great Britain to issue out Writs, in due Form, for Calling a New Parliament; which Writs Form, for Calling a New Parliament; which Writs are to bear Teste on Saturday the Second Day of this instant September, and to be returnable on Tues-

day the 31st Day of October following.

And the Lord Clerk Register, or such Two of the Principal Clerks of the Session as shall be appointed by him to officiate in his Name, are hereby respectively residued to attend such Massium. hereby respectively required to attend such Meeting, and to administer the Oaths required by Law to be taken there by the faid Peers, and to take their Allan Robinson, Gent. Votes; and immediately after such Election made John Macleod, Gent. and duly examined, to certify the Names of the Alexander Rose, Gent.

Sixteen Peers so elected, and sign and attell the fame, in the Presence of the said Peers the Electors; and return such Certificate into Our High Court of Chancery of Great Britain. And We do, by this Our Proclamation, strictly Command and Require the Provost of Edinburgh; and all other the Maciffretes of the said City, to take affective Corn of gistrates of the said City, to take especial Care to preserve the Peace thereof, during the Time of the said Election; and to prevent all Manner of Riots. Tumults, Disorders, and Violence whatsoever. And We strictly Charge and Command, That this Our Royal Proclamation be duly published at the Market Cross at Edinburgh, and in all the County Towns. of Scotland, Twenty five Days, at least, before the Time hereby appointed for the Meeting of the said Peers to proceed to such Election.
