'EDNESDAY last, being the Anniversary of the King's Accession to the Throne, who entered into the Twentyfirst Year of His Reign, there was a numerous and splendid Appearance of the Nobility, Foreign Ministers, and other Persons of Distinction, to compliment His Majesty upon the Occasion. At One o'Clock the Guns in the Park and at the Tower were fired; and in the Evening there were Illuminations, and other Public Demonstrations of Joy, in London and Westminster.
