The KING's Most Excellent Majesty in Council Hereas the Time limited by His Majery's Order in Council of the 18th of August last, for prohibiting the Exporting out of this King-dom, or carrying Coastwife, Gunpowder, Salt-petre, or any Sort of Arms or Ammunition, will expire on the 23d of this instant November: And whereas it is judged expedient that the said Prohibition should be continued for some Time longer, except in those Cases where (for the Benefit and Advantage of Trade, and for the Use and Defence of Ships trading to Foreign Parts, and of the Transports and Victualling Vessels employed in His Majesty's Service) His Majesty, by His several Orders in Council of the 13th and 27th of October, and of the 6th and 22d of November, 1775, of the 5th and 19th of February, and the 23d of August and 25th of September, 1776, of the 16th of April, the September, 1776, of the 16th of April, the 13th of August, and the 3d and 10th of October, 1777, of the 10th of June, the 7th and 26th of August, and the 10th of September, 1778, and of the 17th of May last, has thought proper to permit and allow the Exportation of, and carrying Coastwise, Gunpowder, Saltpetre, Arms and Ammunition, under certain Conditions and Restrictions mentioned in the said Orders: His Majesty doth therefore, by and with the Advice of His Privy Council, hereby order, require, prohibit, and command, that by order, require, prohibit, and command, that no Person or Persons whosoever (except the Master-General, Lieutenant-General, or Principal Officers of the Ordnance, for His Majesty's Service) do, at any Time during the Space of Three Marches to commence from the Side and Day of Months, to commence from the faid 23d Day of this Instant November, presume to transport into carry Parts out of this Kingdom; or carry Coast-wife, any Gunpowder, Saltpetre, or any Sort of Arms or Amagunition, or ship or lade any Gun powder, Saltpetre, or any Sort of Arms or Ammunition, on Board any Ship or Vessel, in order to transporting the same beyond the Seas, or carrying the same Coastwise, except in the Cases com-prized within the aforementioned Orders in Council, without Leave or Permission in that Council, without Leave or Permission in that Behalf sirst obtained from His Majesty or His Privy Council, upon Pain of incurring and suffering the respective Forsettures and Penalties insticted by an Act passed in the 29th Year of His late Majesty's Reign, entituled, "An Act to impower His Majesty to prohibit the Extro portation of Saltpetre, and to enforce the Law for empowering His Majesty to prohibit the Exportation of Gunpowder, or any Sort of Arms and Ammunition; and also to impower His Majesty to restrain the carrying Coastwise "His Majesty to restrain the carrying Coastwife of Saltpetre, Gunpowder, or any Sort of Arms or Ammunition."—And the Lords Commisthe necessary Directions herein, as to them may respectively appertain.
