S several Artificers and Manufacturers, Subjects of Great Britain, have from Time to Time gone into Foreign Countries to exercise their feveral Callings, contrary to the Laws of thefe Kingdoms; The following Abstracts of Two Acts of Parliament of George the First and George the Second, to prevent such Practices, are published for the Information of all Persons who may be ignorant of the Penalties they may incur by Difobedience to them .- And it will be observed, that they extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufactuvers out of these Kingdoms, and in the Exportasion of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themfelves.

Statute 5 George I. Chap. 27.

If any Person shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch maker, or any other Artificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and shall be convicted thereof upon Indictment or Information, in any of the Courts at Westminster, or at the Assizes or Quarter-Sessions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Person having been once convict, shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid. If any of the King's Subjects, being such Arti-

If any of the King's Subjects, being such Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister or Consul of Great Britain, in the Country where such Artiscers shall be, or by any Person authorized by such Ambassador, &c. or by one of the Secretaries of State, and from shall be incapable of taking any Legacy, or of being an Executor or Administrator, and of taking any Lands, &c. within this Kingdom, by Descent, De-

vise, or Purchase; and shall forseit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His Majesty's Protection.

Upon Complaint made upon Oath before any Justice of Peace, that any Person is endeavouring to seduce any such Artificer, or that any such Artificer hath contracted, or is preparing to go out of His Majesty's Dominions, for the Purposes aforesaid; such Justice may send his Warrant to bring the Person complained of before him, or before some other Justice; and if it shall appear by the Oath of one Witness, or by Confession, that he was guilty of any of the said Offences, such Justice may bind him to appear at the next Affizes or Quarter Sessions; And if such Person shall refuse to give Security, the Justice may commit him to Gaol till the next Affizes or Quarter Sessions, and until he shall be delivered by due Course of Law. And if any such Artificer shall be convict upon Indistinent of any such Promise, Contract, or Preparation to go beyond the Seas for the Purposes aforesaid, he shall give such Security to the King, not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the Court of Justiciary, or the Circuits there.

Statute 23 George II. Chap. 13. .

F any Person shall contract with, or endeavour to seduce any Artificer in Wool, Mohair, Cotton or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Country, not within the Dominions of the Crown of Great Britain, and solutions of the Cown of Great Britain, and shall be convicted upon Indictment or Information in the King's Bench at Westminster, or by Indictment at the Assizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indictment in the Court of Justiciary, or any of the Circuit Courts in Scotland; or by Indictment or Information in the King's Bench at Dublin, if such Offence be committed in Ireland; the Person so convicted shall, for every Artificer contrracted with, or feduced, forfeit FIVE HUNDRED POUNDS, and shall suffer Imprisonment in the common Goal of the County or Stewartry wherein such Offender shall be convicted, for Twelve Calendar Months, and until Forfeiture be paid: And in Case of a subsequent Offence of

the same Kind, the Persons so again offending shall | in the same Character) had his first Private Audience forfeit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the common Gaol of the County or Stewartry wherein such Offender shall be convicted, for Two Years, and until fuch Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on Board any Ship or Boat not bound directly to fome Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any fuch Tools or Utenfils as are commonly used in, or proper for the Preparing, Working up or Finishing of the Woollen or Silk Manusactures, or any Part of such Tools, he shall for every Offence forfeit all fuch Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to feize and fecure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as such Officer shall find on Board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools fo feized shall, after Condemnation, be publickly fold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and fecure the fame.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on Board his Vessel, he shall for every such Offence forseit ONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Persons exporting the Tools; and if the Vessel belongs to His Majesty, the Captain shall not only forfeit ONE HUNDRED POUNDS, but shall also forfeit his Employment, and be incapable of any Employment under His Majesty.

If any Officer of the Customs in Great Britain, or of the Revenue in Ireland, take, or knowingly fuffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the faid Tools, or knowingly fuffer the fame to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also forfeit his Office, and be incapable of any Office

under His Majesty.
One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the same.

Admiraly-Office, March 7, 1781. Extract of a Letter from Captain Robert Man, of His Majesty's Ship Cerberus, to Mr. Stephens,

dated Plymouth, March 3, 1781. HAVE the Satisfaction to acquaint their Lord-Thips, that on the 25th of last Month, being about Twenty Leagues West of Cape Finisterre, at Daylight, we saw a Frigate standing to the S. W. On our not answering her private Signals she made Sail from us; we chaced, and at Noon got along-side of her, when after an Action of Fisteen Minutes she of her, when after an Action of Pitteen Minutes ine struck, and proved to be the Grana, a Spanish Frigate, commanded by Don Nicholas De Medina, of 22 Six-pounders, 8 Fours, and 166 Men, from Ferrol, a Month on a Cruize, and had not taken any Thing. The Enemy had her First Lieutenant and Six Men killed, and Seventeen wounded, One of whom is fince dead. In Justice to the Captain and Officers, I believe they did all that was in their Power, but were deserted by their People.

I beg Leave to affure their Lordships, that the Behaviour of the Officers and Ship's Company of the Cerberus was such as merits my utmost Esteem and Recommendation. The Loss the Enemy suftained in so short an Action induces me to think, that had she been of greater Force I should equally have the Pleasure of writing a similar Letter.

The Cerberus had only Two Men slightly hurt.

which leads to St. Paul's Church-yard, where he took a Pair of Psstols and Portmanteau under his Arm, and walked towards the Church-yard.

The faid George Weston is described to be about Five Feet Six or Seven Inches high, about Twenty-four or Twenty-five Years of Age, his Hair of a lightish Brown Colour, cut short before, and tied behind, fresh coloured, pitted with the Small Pox, thin made, speaks quick, and when he arrived in London had Boots on, and a light coloured Great Coat. He lodged at the Coventry Cross, in Potters-fields, Tooley-fireet, about Four Months ago, has a Brother named Joseph Weston, and both are reputed to be Highwaymen.
