the War that now subsists in the Carnatic, and of the present Condition of the British Possessions in those Paris, to attend the faid Committee on the preceding Day, and also on the First Day of this Instant May, had neglected so to do; it was thereupon ordered by the faid House of Commons, that Thomas Lewin, Esquire, should be taken into Custody of the Serjeant at Arms attending the faid House of Commons: And whereas the faid Serjeant at Arms having been called upon to give an Account of what had been done in relation to the taking the said Thomas Lewin, Esquire, and the Messenger who was fent in Search of him being called in and examined, and having acquainted the House that he had withdrawn himself and was not taken, an humble Address has been prefented to Us by the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs, in Parliament assembled, that We would be graciously pleased to issue Our Royal Proclamation for apprehending the faid Thomas Lewin, with a Promite of a Reward for the same; We have thought fit, by and with the Advice of Our Privy Council, to issue this Our Royal Proclamation, hereby requiring and commanding all Our loving-Subjects what soever, to discover and apprehend, or cause the faid Thomas Lewin to be discovered and apprehended, and to carry him before some of Our Justices of the Peace, or Chief Magistrates of the County, Town, or Place, where he shall be apprehended who are respectively required to secure the said Thomas Lewin, and thereof give speedy Notice to One of Our Principal Secretaries of State, to the End he may be forthcoming to be dealt withal and proceeded against according to Law.—And for the Prevention of an Escape of the said Thomas Lewin into Parts beyond Seas, We do require and command all Our Officers of the Customs, and other Our Officers and Subjects of aad in Our respective Por's, and Maritime Towns and Places within Our Kingdom of Great Britain, that they and every of them, in their respective Places and Stations, careful and diligent in the Examination of all Persons that shall pass or endeavour to pass beyond the Seas, and if they shall discover the said Thomas Lewin, then to cause him to be apprehended and ficured, and to give Notice thereof as afore-faid: And We do hereby firifly charge and command all Our loving Subjects, as they will an fwer the contrary at their Perils, that they do not any ways conceal, but do discover him the said Thomas Lewin, to the End he may be secured : And for the Encouragement of all Persons to be diligent and careful, in endeavouring to discover and apprehend the faid Thomas Lewin, We do hereby further dectare, that who loever shall discover and apprehend the said Thomas Lewin, and shall bring him the faid Thomas Lewin before fome Justice of the Peace, or Chief Magistrate as aforesaid, shall have and receive, as a Reward for the discovering, apprehending, and bringing the said Thomas Lewin before such Justice of the Peace, or Chief Magistrate as aforesaid, the Sum of Five Hundred Pounds, which Our Commissioners of Our Treasury are hereby required and directed to pay accordingly.

HEREAS many Seamen have, from Time to Time, inconfiderately deferted His Majesty's Service, by leaving the Ships they belonged to, as they could find Opportunity for fo doing, or, having been put on Shore Sick from His Majesty's Ships, either into Hospitals or Sick Quarters, have made so ill a Return to the Care taken for their Healths as to desert from His Majesly's Service, when so far recovered as to be able to withdraw themselves from the said Hospitals or Sick Quarters; for which Crimes they have incurred the Loss of their Wages, and are punishable with Death by a Court Martial: But my Lords Commissioners of the Admiralty being willing to impute fuch Desertion into a Rashness which most of them soon repent of, and believing that they would return to their Ships, were it not from Apprehensions of Punish ment; in order therefore to remove fuch Apprehensions, and encourage them to return to their Duty, there Lordships do hereby declare, That if any Persons who have deserted as aforesaid shall, ou on or before the Thirtieth Day of June next, return to the Ships to which they did belong, or, in case those Ships are gone Abroad, enter themselves on Board some other of His Majetty's Ships, they shall not be punished in any Manner whatsoever, on Account of the Crimes they have committed in withdrawing themselves from His Majesty's Service as aforesaid, excepting such as have been guilty of Mu-tiny, or any other notorious Crimes: And, as a further Encouragement, their Lordships are pleased to declare, that such as shall so return shall have their Rs taken off, and be paid their Wages for the Ships from which they respectively deserted; but their Lordships do also think fit to declare, that all Persons under the above-mentioned Circumstances, who do not make a proper Use of the In-dulgence hereby offered them, will be strictly sought after, and, (in case they are apprehended) brought to a Court Martial, and treated as the Law directs.
