HEREAS, upon Information re-ceived that the Plague had broke out at Cherson, at Oczakow, in the Coun-land, His Majesty was pleased, by His Order in Council of the 25th of July last, to direct, that all Ships and Vessels then arrived, or that should thereafter arrive from Dantzick, or any other Port or Place in Royal or Ducal Pruffia or Pomerania, should make their Quarantine for Forty Days: And whereas there was this Day read at the Board a Letter from the Right Honourable Lord Viscount Dalrymple, His Majesty's Minister Plenipotentiary at Warsaw, stating, that notwithstanding the Reports that had been spread, the Plague had not appeared in any Part of Poland; and that, according to the last Letters from Cheron, no Symptoms of that Disorder had been discovered there since the Beginning of June: His Majesty, taking the same into Consideration, and being defirous to remove all Restraints upon Trade, so far as may be confishent with the Safety of His Subjects, is pleased, with the Advice of His Privy Council, to order, as it is hereby ordered, that the Quarantine at present substitting upon all Ships and Vessels coming from Dantzick, or any other Port or Place in Royal or Ducal Prussa or Pomerania, be taken off; and that all Ships and Vessels already arrived, or that may hereafter arrive from those Places, be permitted to discharge their respective La dings, without unpacking, opening and airing, and without performing any Quarantine; provided that the Master or other Person taking Charge of such Ship or Vessel, do first make Oath before the Cus tom-House Officer or Chief Magistrate at the Place to which such Ships are bound, that their Crews are free from all Infection, and that they have not had Communication with any Ship or Vessel coming from any infected Place.—And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for Executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master General of the Ordnance, His Majesty's Secretary
