The KING's Most Excellent Majesty in Council HEREAS His Majesty hath received Information, that the Plague doth at this Time rage with great Violence in divers
Parts of the Levant, and at Tunis, and on the Coast of Barbary; and that in consequence of the Prevalence thereof, and of some Suspicions attending a Ragusan Ship arrived at Tangier from Alexandria, a rigorous Quarantine has been laid, by Order of the King of Spain, on Vessels coming from any Part of the Coasts of the Mediterranean, except those Ports which are at War with the Grand Signor, and the Barbary States: And whereas His Majesty hath also received Information, that a Vessel lately arrived at Marseilles with the Plague on Board, and that Six or Seven Persons, who had frequented her, had died in the Lazarette of that Place; His Majesty this Day took the fame into Confideration; and although it appeared that a Quarantine of Forty Days is at this Time subsitting, by Orders of this Board, upon all Ships and Vessels coming from or through the Mediterranean (except those coming directly from any of the Ports of the Kingdom of Spain, or from the Island of Minorca, or from the Town or Port of Gibraltar) yet His Majesty, with the Advice of the Company of Com His Privy Council, judges it necessary upon this Occasion to cause the said Orders to be inforced and extended; and to that End His Majesty, with the Advice aforesaid, doth hereby order, require and command, that the said Quarantine be enforced, and that all the Officers appointed for the Service of Quarantine do use their utmost Care and Diligence in causing the several Rules and Regulations, established for the due Performance of Quarantine, to be punctually and strictly observed and carried into Execution: And His Majesty, with the Advice of His Privy Council, is further pleased to order, require and command, that all Ships and Vessels whatsoever, coming from any of the Ports of the Kingdom of Spain, within the Mediterranean, or from Minorca or Gibraltar, and all Goods and Merchandizes on Board the same, that are already arrived, or that shall here fter arrive in any of the Ports of this Kingdom, or of the Isles of Jersey, Guernsey, Alderney, Sark or Man, do make their Quarantine for Forty Days, and do likewise strictly conform themselves in all Respects to the Rules and Regulations now in Force, and required to be observed by Ships and Vessels subject to Quarantine. And the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the

Lord Warden of the Cinque Ports, the Master-General of the Ordnance, His Majesty's Secretary at War, and the Governors or Commanders in Chief for the Time being of the said respective Isles of Jersey, Guernsey, Alderney, Sark and Man, are to give the necessary Directions herein, as to them may respectively appertain.

The KING's Most Excellent Majesty in Council.

HEREAS by virtue of an Ast made in the last Session of Parliament, intituled, "An Act to extend the Powers of an Act made in the "Twenty-third Year of His present Majesty, for giving His Majesty certain Powers for the better carrying on Trade and Commerce between the " Subjects of His Majesty's Dominions and the In-"habitants of the United States of America, to the Trade and Commerce of this Kingdom with the British Colonies and Plantations in America, with Respect to certain Articles therein mentioned;" His Majesty doth, by and with the Advice of His Privy Council, hereby order and declare, that, until further Order, there shall be allowed and paid the fame Drawbacks upon the Exportation of any Sort of Foreign Hemp, or Foreign Iron, exported into Great Britain into any British Colony or Plantation in America, or into the Territories of the United States of America, or any of them, as are or may be allowed by Law, upon the Exportation of the like Sort of Hemp or Iron, and under the same Rules. Regulations, Restrictions, Penalties and Forfeitures, in all Respects, as such Drawbacks are allowed and paid, or are subject and liable to by Law, upon the Exportation of such Hemp and Iron into other Foreign Parts.—And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to give the necessary Directions herein, as to them may respectively appertain.

AS Several Artificers and Manufacturers, Subjects of Great Britain, have from Time to Time gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms; The following Abstracts of Two Acts of Parliament of George the First and George the Second, to prevent such Practices, are published for the Information of all Persons rubo may be ignorant of the Penalties they may incur by Disobedience to them .- And it will be observed, that they extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, and in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themselves.

#### Statute's George I. Chap. 27.

IF any Person shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries, out of the King's Dominions, and shall be convicted thereof upon Indictment or Informa-tion, in any of the Courts at Westminster, or at the Affizes or Quarter-Seffions, he shall be fined any Sum not exceeding ONE HUNDRED POUND's or the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Per-fon having been once convict, shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being such Arti-

ficers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any fuch Foreign Country, exercifing any of the faid Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister or Consul of Great Britain, in the Country where such Artisicers shall be, or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from thenceforth inhabit within this Realm; such Person shall be incapable of taking any Legacy, or of being an Executor or Administrator, and of taking any Lands, &c. within this Kingdom, by Descent, Devise or Purchase; and shall forfeit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alten, and out of His

Majesty's Protection.

Upon Complaint made upon Oath before any Justice of Peace that any Person is endeavouring to feduce any such Artificer, or that any such Artificer hath contracted, or is preparing to go out of His Majesty's Dominions, for the Purposes afore-faid; such Justice may send his Warrant to bring the Person complained of before him, or before fome other Justice; and if it shall appear by the Oath of one Witness, or by Confession, that he was guilty of any of the said Offences, such Justice may bind him to appear at the next Assizes or Quarter Sesfions: And if such Person shall refuse to give Security, the Justice may commit him to Goal till the next Affizes or Quarter Selfions, and until he shall be delivered by due Course of Law. And if any fuch Artificer shall be convicted upon Indictment of any fuch Promise, Contract, or Preparation to go beyond the Scas for the Purpose aforesaid, he shall give such Security to the King, not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland the same shall be prosecuted in the Court of Justiciary, or the Circuits there.

Statute 23 George II. Chap. 13.

IF any Person shall contract with, or endeavour to seduce any Artificer in Wool, Mohair, Cotton or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Country, not within the Dominions of the Crown of Great Britain, and shall be convicted upon Indictment or Information in the King's Bench at Westminster, or by Indistment at the Assizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indictment in the Court of Justiciary, or any of the Circuit Courts in Scotland, or by Indicament or Information in the King's Bench at Dublin, if such Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with, or feduced, forfeit FIVE HUNDRED POUNDS, and shall suffer Imprifonment in the Common Goal of the County or Stewartry wherein such Ossender shall be convicted, for Twelve Calendar Months, and until Foreiture be paid: And in Case of a subsequent Offence of fame Kind, the Persons so again offending shall forfeit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein such Offender, shall be convicted, for Two Years, and until fuch Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on Board any Ship or Boat not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Bri-

tain, any such Tools or Utensils as are commonly used in, or proper for the Preparing. Working up or Finishing of the Woollen or Silk Manusacturers or any Part of such Tools, he shall for every Offence forseit all such Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts, in Dublin respectively, wherein no Ession, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as such Officer shall sind on goard any Vessel not bound circuity to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all It ols so seized shall, after Condemnation, be publickly sold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and secure the same.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the said Tools, prohibited to be exported, to be put on Board his Vessel, he shall for every such Offence forseit ONE HUNDRED POUNDS, to be recovered as the Penalties insticted upon Persons exporting the Tools; and if the Vessel belongs to His Majesty, the Captain shall not only forseit ONE HUNDRED POUNDS, but shall also sorseit his Employment, and be incapable of any Employment under His Majesty.

If any Officer of the Customs in Great Britain, or of the Revenue in Ireland, take, or knowingly suffer to be taken, any Entry outward, or sign any Cocket or Sufferance for the Shipping or Exporting of any of the said Tools, or knowingly suffer the same to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also forfeit his Office, and be incapable of any Office

under His Majesty.

One Moiety of the Forseitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the same.
