HEREAS His Majeity hath received Information, that the Plague doth at this Time rage with great Violence in divers Parts of the Levant, and at Tunis, and on the Coast of Barbary; and that in confequence of the Prevalence thereof, and of some Suspicions attending a Ragusan Ship arrived at Tangier from Alexandria, a rigorous Quarantine has been laid, by Order of the King of Spain, on Vessels coming from any Part of the Coasts of the Mediterranean, except those Ports which are at War with the Grand Signor, and the Burbary States: And whereas His Majesty hath also received Information, that a Vessel lately arrived at Marseilles with the Plague on Board, and that Six or Seven Persons, who had frequented her, had died in the Lazarette of that Place; His Majesty this Day took the same ir to Consideration; and although it appeared that a Quarantine of Forty Days is at this I ime subsiding, by Orders of this Board, upon all Ships and Veffels coming from or through the Mediterranean (except thole coming directly from any or the Ports of the Kingdom of Spain, or from the Island of Minorca, or from the Town or Port of Gibraltar) yet His Majesly, with the Advice of His Privy Council, judges it necessary upon this Occasion to cause the said Orders to be inforced and extended; and to that End His Majesty, with the Advice aforesaid, doth hereby order, require and command, that the faid Quarantine be enforced, and that all the Officers appointed for the Service of Quarantine do use their utmost Care and Diligence in causing the several Rules and Regulations, established for the due Performance of Quarantine, to be punctually and strictly observed and carried into Execution: And His Majesty, with the Advice of His Privy Council, is further pleased to order, require and command, that all Ships and Vessels whatsoever, coming from any of the Ports of the Kingdom of Spain, within the Mediterranean, or from Minorca or Gibraltar, and all Goods and Merchandizes on Board the same, that are already arrived, or that shall here fier arrive in any of the Ports of this Kingdom, or of the Isles of Jersey, Guernsey, Alderney, Sark or Man, do make their Quarantine for Forty Days, and do likewise strictly conform themselves in all Respects to the Rules and Regulations now in Force, and required to be observed by Ships and Vessels subject to Quarantine. And the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-Ge neral of the Ordnance, His Majesty's Secretary at War, and the Governors or Commanders in Chief for the Time being of the said respective Isles of Jersey, Guernsey, Alderney, Sark and Man, are to give the necessary Directions herein, as to them may respectively appertain.

Constantinople, August 9. On the 3d Instant the Porte received certain Intelligence that a terrible Earthquake had happened on the 23d of July, in the mountainous Parts in the Province of Ekilis, towards the Frontiers of Armenia, by which the Town of Ezerghen or Arfingham, about Fifty Miles on this Side of Erzerum, had been nearly destroyed, with the Loss of about Six Thousand Inhabitants. Amongst other Sufferers by this dreadful Calamity was Suleiman, Pashaw of Erzerum, lately promoted to that Government from the Post of Citaus Bashi, Chief of the Pursuivants. This Gentleman had proceeded as far as Ezirghen, with a Suite of Five Hundred People, of whom Twelve only escaped.

At Mid-day on the 5th Instant, the North Wind being remarkably high, a Fire broke out in the Quarter of Constantinople called Chiremit Mahalesi, fituated towards the Bottom of the Harbour, which, for Want of timely Affistance, foon communicated to different Houses; and, in less than Two Hours, extended to the Town Walls towards Fanar, and to the Quarters of Cara-Ghiumruk, Jeni Bakzé, and Sara Gheriz. It continued burning Twenty fix Hours, and about Ten Thousand Houses (most of which had been rebuilt fince the Fire in 1782) were

entirely confumed.

That Letters and Packets above 150 Miles, within England, shall pay in Addition, Single 2d. and so in Proportion.
