PROCLAMATION,

For Recalling and Probibiting Seamen from Serving Foreign Princes and States.

GEORGE R. HEREAS it hath been represented unto Us, That Attempts are made to entice Mariners and Seafaring Men, Our natural born Subjects, to enter into the Service of Foreign Princes and States, contrary to their Duty to Us, and without Regard to the perfect Amity now subfishing between Us and all the other Powers of Europe; We have therefore thought it necessary, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation; and do hereby strictly charge and command all Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, and other Seafaring Men whatsoever and wheresoever, (being Our naturalborn Subjects) who may have entered into the Pay or Service of any Foreign Prince or State, or do serve in any Foreign Ship or Vessel, without Our special Licence and Authority in that Behalf heretofore obtained, that forthwith they and every of them do (according to their known and bounden Duty and Allegiance) withdraw themselves, depart from, and quit such Foreign Services, and return Home to their native Countries: And further We do hereby strictly prohibit and forbid all Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, and other Seafaring Men whatsoever (being Our natural-born Subjects) from entering, and do charge and command them, and every of them, from henceforth to forbear to enter themselves into the Pay or Service of any Foreign Prince or State, or to ferve in any Foreign Ship or Vessel whatsoever, without Our special Licence first had and obtained in that Behalf; to all which We expect due Obedi-ence and exact Conformity: And We do hereby publish and declare, that the Offenders to the contrary shall not only incur Our just Displeasure, but be proceeded against for their Contempt according to the utmost Severities of the Law: And We do hereby declare, that if any such Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, or other Seafaring Men (being Our Subjects) shall be taken in any Foreign Service, by the Turks, Algerines, or any others, they shall not be reclaimed by Us as Subjects of Great Britain.

Given at Our Court at St. James's, the Nineteenth Day of November, One thousand seven hundred and eighty-four, in the Twenty-fifth Year of Our Reign.

## St. James's, August 28.

AS several Artificers and Manufacturers, Subjects of Great Britain, have from Time to Time gone into Foreign Countries to exercise their several Callings. contrary to the Laws of these Kingdoms; The following Abstracts of Two Ads of Parliament of George the First and George the Second, to present such Practices, are published for the Information of all Persons who may be ignorant of the Penaltits they may incur by Disobedience to them .- And it will be objerved, that they extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, and in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themselves.

Statute 5 George I. Chap. 27.

IF any Person shall contract with, entice, or solicit, any Artissicer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries, out of the King's Dominions, and shall be convicted thereof upon Indictment or Information, in any of the Courts at Westminster, or at the Affizes or Quarter-Sessions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS or the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Perfon having been once convict, shall offend again, he

shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid. If any of the King's Subjects, being such Arti-

ficers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any fuch Foreign Country, exercising any of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister or Consul of Great Britain, in the Country where such Artificers shall be, or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from thenceforth inhabit within this Realm; such Person shall be incapable of taking any Legacy, or of being an Executor or Administrator, and of taking any Lands, &c. within this Kingdom, by Descent, Devise or Purchase; and shall forfeit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His Majesty's Protection.

Upon Complaint made upon Oath before any Justice of Peace that any Person is endeavour-ing to seduce any such Artificer, or that any such Artificer hath contracted, or is preparing to go out of His Majesty's Dominions, for the Purposes aforefaid; such Justice may send his Warrant to bring the Person complained of before him, or before some other Justice; and if it shall appear by the Oath of one Witness, or by Confession, that he was guilty of any of the faid Offences, such Justice may bind him to appear at the next Affizes or Quarter Seffions: And if fuch Person shall refuse to give Security, the Justice may commit him to Goal till the next Assizes or Quarter Sessions, and until he shall be delivered by due Course of Law. And if any

fuch Artificer shall be convicted upon Indictment of any fuch Promise, Contract, or Preparation to go beyond the Seas for the Purpose aforesaid, he shall give such Security to the King, not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security

If any of the above Offences shall be committed in Scotland the same shall be prosecuted in the

Court of Justiciary, or the Circuits there.

Statute 23 George II. Chap. 13. TF any Person shall contract with, or endeavour to seduce any Artificer in Wool, Mohair, Cotton or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or Any Cook in any of the Manufacture of the Manufacture. any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Country, not within the Dominions of the Crown of Great Britain, and shall be convicted upon Indictment or Information in the King's Bench at Westminster, or by Indictment at the Afrizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indictment in the Court of Judiciary, or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if fuch Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with, or seduced, forset FIVE HUNDRED POUNDS, and shall suffer Impriforment in the Common Goal of the County or Stewartry wherein such Ossender shall be convicted, for Twelve Calendar Months, and until Foreiture be paid: And in Case of a subsequent Offence of the same Kind, the Persons so again offending shall forfeit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein such Offender shall be convicted, for Two Years, and until such Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on Board any Ship or Boat not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any fuch Tools or Utenfils as are commonly used in, or proper for the Preparing, Working up or Finishing of the Woollen or Silk Manufacturers or any Part of such Tools, he shall for every Offence forseit all such Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts, in Dublin respectively, wherein no Essoin, &c.

shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as such Officer shall find on goard any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools fo feized shall, after Condemnation, be publickly fold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and fecure the fame.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on Board his Vessel, he shall for every such Offence forfeit ONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Persons exporting the Tools; and if the Vessel belongs to His Majesty, the Captain shall not only forfeit ONE HUN.

DRED FOUNDS, but shall also forfeit his Em-.. ployment, and be incapable of any Employment

If any Officer of the Customs in Great Britain, or of the Revenue in Ireland, take, or knowingly fulfier to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting from to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also sorfeit his Office, and be incapable of any Office under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiery to the Use of the Person who shall sue for the same.

WHERE AS it hath been humbly represented to the King, that about Four o' lock in the Morning of the 1'5th Day of September last, a Ship or Keffel called the Ebenezer, of Pensgrund, in Norway, James Neilson, Master, laden with Deals, and bound for Briftol, struck upon the Goodwin Sands .- That the Master basing made Signals of Distress, about Twenty Persons came in Boats from Ramsgate, and were employed by him in getting the Ship off the Sands, which they would in all Probability bave estended, but were interrupted in and prevented from using the proper Mehns for that Purpose, by upwards of Two Hundred Persons, who came from Deal, and by Force and Violence boarded the said Ship, abused and ill-treated she said Naster and his Crew, broke open the Ship's Hatches and Lockers, scuttled her Decks and Cabbin, and plundered the said Ship of Parts of her Cargo; and in order to prevent her being got off the Sands, some of them cut away the Ship's Cable and Parts of her Shrouds, and drove out the Bolts of the Bit Head, whereby he Windlas was so disabled that no farther Means could be used for her Preservation; and the Master and his Crew were obliged to quit their Ship, which was afterwards found asseat in the Gull Stream.

His Majesty, for the apprehending and bringing to Justice the Persons concerned in the several Acts of Piracy and Felony aforefaid, is bereby pleased to promise His most gracious Pardon to any one of them, who shall discover his Accomplice or Accomplices therein, so that he or they may be apprehended and

convicted thereof.

And, as a further Encouragement, His Majesty also is pleased to promise a Reward of TWO HUNDRED POUNDS, to any Person making such Discovery as asoresaid, to be paid by the Lords Commissioners of His Majesty's Treasury, upon the Convidion of any one or more of the Offenders.
