A S feveral Artificers and Mannfailurers, Subjets of Great Britain, have from Fime to Time gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms; The following Abstracts of Two Acts of Parliamen: of George the First and George the Second, to prevent such Practices, are published for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them.—And it will be observed, that they extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, and in the Export ation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themselves.

#### Statute 5 George 1. Chap. 27.

IF any Perfon shall contract with, entice, or folicit; any Artificer in Wool, Iron, Steel, Brafs, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries, out of the King's Dominions, and shall be convicted thereof upon Indictment or Information, in any of the Courts at Westminster, or at the Affizes or Quarter-Sessions, he shall be fined any Sum not exceeding ONE HUNDRED POUND3 or the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Ferfon having been once convict, shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being fuch Artificers, fhall go into any Country out of His Majefty's Dominions, to exercife or teach the faid Trades to Foreigners; and if any of the King's Subjects in any fuch Foreign Country, exercifing any of the faid Trades, fhall not return into this Realm within Six Months after Warning given by the Ambaffador, Minifter or Conful of Great Britain, in the Country where fuch Artificers fhall be, or by any Perfon authorifed by fuch Ambaffador, &c. or by one of the Secretaries of State, and from thenceforth inhabit within this Realm ; fuch Perfon fhall be incapable of taking any Legacy, or of being an Executor or Adminiftrator, and of taking any Lande, &c. within this Kingdom, by Defcent, Devife or Purchafe; and fhall forfeit all. Lands, Goods, &c. within this Kingdom, to His Majefty's Ufe, and fhall be deemed Al en, and out of His Majetly's Protection.

Upon Complaint made upon Oath before any Juitice of Peace that any Perfon is endeavouring to feduce any fuch Artificer, or that any fuch Artificer hath contracted, or is preparing to go out of this Majcity's Dominions, for the Purpofes aforefaid; fuch Juffice may fend his Warrant to bring

the Perfon complained of before him, or before fome other Juffice; and if it thall appear by the Oath of one Witnefs, or by Confeffion, that he was cally of any of the faid Offences, fuch Juffice may could him to appear at the next Affizes or Quarter Seffons: And if fuch Perfon fhall refue to give Secarity, the Juffice may commit him to Goal till the next Affizes or Quarter Seffions, and until he fhall be delivered by due Courfe of Law. And if any fuch Artificer thall be convicted upon Indiciment of any fuch Promife. Contract, or Preparation to go beyond the Seas for the Purpofe aforefaid, he fhall give fuch Security to the King, not to depart out of His Majefly's Dominions, as fuch Court thall think reafonable, and fhall be imprifoned till Security given.

If any of the above Offences shall be committed in Scotland the same shall be profecuted in the Court of Justiciary, or the Circuits there.

#### Statute 23 George II. Chap. 13.

FF any Perfon shall contract with, or endeavour to feduce any Artificer in Wool, Mohair, Cot-ton or Silk, or in Iron, Steel, Brafs, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufac-tures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Coun-try, not within the Dominions of the Crown of Great Britain, and shall be convicted upon indictment or Information in the King's Bench at Westminster, or by Indictment at the Affizes or General Gaol Delivery for the County, &c. wherein fuch-Offence shall be committed in England, or by Indictment in the Court of Jufficiary, or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Berch at Dublin, if fuch Offence be committed in Ireland ; the Perfon fo convicted fhall, for every 2r -. tificer contracted with, or feduced, forfeit FIVE HUNDRED POUNDS, and shall fuffer Imprifonment in the Common Goal of the County or Stewartry wherein fuch Offender shall be convicted, for Twelve Calendar Months, and until Foreiture be paid : And in Cafe of a fubfequent Offence of the fame Kind, the Perfons fo again offending hall forfeit, for every Perlon contracted with or feduced, ONE THOUSAND POUNDS, and shall fuffer Imprisonment in the Common Gaol . of the County of Stewartry wherein fuch Offender shall be convicted, for Two Years, and until fuch Forfeiture be paid.

If any Perfon in Great Britain or Ireland fhall put on Board any Ship or Boat not bound directly to fome Port in Great Britain or Ireland, or to fome other of the Dominions of the Crown of Great Britain, any fuch Tools or Utenfils as are commonly ufed in. or proper for the Preparing, Working up or Finithing of the Woollen or Silk Manufacturers or any Part of fuch Tools, he fhall for every Offence forfeit all fuch Tools, or Parts thereof, put an on Board, and TWO HUNDRED POUNDS, to be recovered by A&ion of Debt, &c. in any Court of Record at Weltminiller, or in the Court of Seffion in Scotland, or at any of the Four Courts, in Dublin respectively, wherein no Effoin, &c. fhall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to feize and secure, in some of His Ma-jetty's Warehouses, all such Tools or Utensils prohibited to be exported, as fuch Officer shall find on goard any Veffel not bound directly to some Port in Great Britain or Ireland, or to fome other of the Dominions of the Crown of Great Britain ; and all Tools fo feized shall, after Condemnation, be publickly fold to the beft Bidder; and one Moiety of the Produce shall be to the Use of His Majely, and the other Moiety to the Officer who shall feize and fecure the fame.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on Board his Veffel, he thall for every fuch Offence forfeit ONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Perfons exporting the Tools; and if the Veffel belongs to His Majelly, the Captain shall not only forfeit ONE HUN-DRED POUNDS, but shall also forfeit his Employment, and be incapable of any Employment under His Majefly.

If any Officer of the Customs in Great Britain, or of the Revenue in Ireland, take, or knowingly fuffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the faid Tools, or knowingly fuffer the fame to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforefaid, and alfo forfeit his Office, and be incapable of any Office under His Majefty. One Moiety of the Forfeitures shall be applied

to the Use of His Majesty, and the other Moiety to the Ufe of the Perfon who shall fue for the fame.
