The King has been pleased to appoint Ralph Woodford, Esq; late His Majesty's Envoy Extraordinary to the Court of Denmark, to be His Majesty's Commissary to treat with the Commisfary of the Catholick King concerning new Ar-rangements of Commerce, purfuant to the De-finitive Treaty of Peace and Friendship, concluded between the Two Crowns at Verfailles, the zd of September, 1783.

Vienna, January 1.

The Nobility of both Sexes, and the Foreign Ministers, had the Honour of paying their Court this Morning to the Emperor, who afterwards dined in Public.

Paris, January 4.

Letters from Briançon mention, that a Shock of an Earthquake was felt there the 9th Ult. at Ten Minutes after Nine o'Clock in the Morning. The Concufion was pretty frong, but of flort Duration, attended with a rumbling Noife which refembled the Report of Cannon. There was no perceptible Vibration; but, during feveral Nights previous to the Shock, fiery Vapours were observed to issue from the Earth in various Parts near the Coal Mines.

St. James's, August 28.

AS feweral Artificers and Manufacturers, Subjects of Great Britain, bave from Time to Time gone into Foreign Countries to exercise their several Callings; contrary to the Laws of these Kingdoms; The following Abstracts of Two Acts of Parliament of George the First and George the Second, to provent fuch Practices, are published for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them.—And is will be observed, that they extend to those who are any ways concerned or infrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, and in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themselves.

Statute 5 George I. Chap. 27.

IF any Perfon shall contract with, entice, or folicit, any Artificer in Wool, Iron, Steel, Brafs, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries, out of the King's Dominions, and shall ^che

tion, in any of the Courts at Westminster, or at the Affizes or Quarter-Seffions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS or the first Offence, and shall be imprisoned Three Months, and till the Fine he paid. And if any Perfon having been once convict, shall offend again, he shall be fined at the Discretion of the Court, and imprifoned Twelve Months, and till the Fine be

paid. If any of the King's Subjects, being fuch Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the faid Trades to Foreigners; and if any of the King's Subjects in any luch Foreign Country, exerciling any of the faid Trades, shall not return into this Realm within Six Months after Warning given by the Ambaffador, Minister or Conful of Great Britain, in the Country where such Artificers shall be, or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from thenceforth inhabit within this Realm ; fuch Perfon fhall be incapable of taking any Legacy, or of being an Executor or Administrator, and of taking any Lands, &c. within this Kingdom, by Defcent, De-vife or Purchafe; and shall forfeit all Lands, Goods, &c. within this Kingdom, to His Majefty's Use, and shall be deemed Alien, and out of His Majefty's Protection.

Upon Complaint made upon Oath before any Justice of Peace that any Person is endeavouring to feduce any fuch Artificer, or that any fuch Artificer hath contracted, or is preparing to go out of His Majefty's Dominions, for the Purpofes aforefaid; fuch Justice may fend his Warrant to bring the Person complaned of before him, or before fome other Justice; and if it shall appear by the Oath of one Witness, or by Confession, that he was guilty of any of the faid Offences, fuch Justice may bind him to appear at the next Affizes or Quarter Seffions : And if fuch Perfon shall refuse to give Security, the Justice may commit him to Goal till the next Affizes or Quarter Selfions, and until he shall be delivered by due Course of Law. And if any fuch Artificer shall be convicted upon Indictment of any fuch Promife, Contract, or Preparation to go beyond the Seas for the Purpose aforefaid, he shall give fuch Security to the King, not to depart out of His Majesty's Dominions, as fuch Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland the fame shall be profecuted in the Court of Jufficiary, or the Circuits there.

Statute 23 George II. Chap. 13.

IF any Perfon shall contract with, or endeavour to feduce any Artificer in Wool, Mohair, Cotton or Silk, or in Iron, Steel, Brafs, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Country, not within the Dominions of the Crown of Great Britain, and shall be convicted upon Indictment or Information in the King's Bench at Westminster, or by Indictment at the Assizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indiament in the Court of Jufficiary, or any of the Circuit Courts in Scotland, or by

be convicted thereof upon Indictment or Informa- | Indictment or Information in the King's Bench at Dublin, if fuch Offence be committed in Ireland; the Perfon fo convicted shall, for every Artificer contracted with, or feduced, forfeit FIVE HUNDRED POUNDS, and shall suffer Impri-fonment in the Common Goal of the County or Stewartry wherein such Ossender shall be convicted, for Twelve Calendar Months, and until Foreiture be paid : And in Cafe of a subsequent Offence of the fame Kind, the Perfons fo again offending thall forfeit, for every Person contracted with or feduced, ONE THOUSAND POUNDS, and shall fuffer Imprisonment in the Common Gaol of the County or Stewartry wherein fuch Offender fhall be convicted, for Two Years, and until fuch Forfeiture be paid.

If any Perfon in Great Britain or Ireland shall put on Board any Ship or Boat not bound directly to fome Port in Great Britain or Ireland, or to fome other of the Dominions of the Crown of Great Britain, any fuch Tools or Utenfils as are commonly. ufed in, or proper for the Preparing, Working up or Finishing of the Woollen or Silk Manufacturers or any Part of such Tools, he shall for every Offence forfeit all fuch Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Weitminster, or in the Court of Seffion in Scotland, or at any of the Four Courts, in Dublin respectively, wherein no Essoin, &c. fhall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to feize and fecure, in fome of His Majefty's Warehouses, all fuch Tools or Utenfils prohibited to be exported, as fuch Officer shall find on Board any Vessel not bound directly to fome Port in Great Britain or Ireland, or to fome other of the Dominions of the Crown of Great Britain; and all Tools fo feized shall, after Condemnation, be publickly fold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who fhall feize and fecure the fame.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on Board his Vellel, he shall for every such Offence forfeit ONE HUNDRED POUNDS, to be recovered as the Penaltics inflicted upon Perfons exporting the Tools; and if the Veffel belongs to His Majefly, the Captain shall not only forfeit ONE HUN-DRED POUNDS, but shall allo forfeit his Employment, and be incapable of any Employments under His Majefty. If any Officer of the Cuftoms in Great Britain, (1,1,1)

or of the Revenue in Ireland, take, or knowingly. fuffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the faid Tools, or knowingly fuffer the fame to be done, he shall forfeit ONE HUNDRED FOUNDS, to be recovered as aforefaid, and alfo forfeit his Office, and be incapable of any Office under His Majefty.

One Moiety of the Forfeitures shall be applied to the Ufe of His Majelty, and the other Moiety to the Use of the Person who shall fue for the fame.

WHEREAS it has been humbly represented to the King, That, on Tuesday the 10th Day of August Inf, John Fifter, Commander of the Hunter Cutter, in the Service of His Majefty's Cuftoms at the Port of Yarmouth, being on a Cruize, about Six o'Clock in the Escuing, difcovered a Lugger coming round Foulnefs, and, suspecting ber to be a Smugler, gave chafe, but a thick Fog coming on, lost Sight of her for a small Space of Yime: That being informed the faid Lugger had failed to the Southward, he manned bis Ten oar'd Boat, under the Command of Robert Jay, his Second Mate, with Ralph Newby and Eleven JAY, SIS Second Wate, With Kapp Newby and Bueven others, who, foon after Day-Light in the Morning of the 14th of August aforefaid, came up with the faid Lugger at Buston Bay, on the Coast of Norfolk, and within the Limits of the Port of Yarmouth, and found her to be the Baston Lugger, Charles Gee, M. Am. That who Officer attended Master : That on the Officers approaching the Lugger, they were fired upon by the Smuglers on board the jaid Lugger, which was returned by the Officers firing I wo Mufkets over their Heads : But that the Officers fill perfifting in doing their Duty, and endeavouring Fill performs in acong their Duty, and endeavouring to board the faid Lugger, the Firing from her was continued, and Charles Gee, the Master, with a Blunderbuss, pointed at the faid Robert Jay, shot him through the Body, of which Wound he died in less than Half an Hour afterwards; and that at the Time the faid Charles Gee fired the Blunderbuss, the Custum-House Boat was within Three or Four Yards of the Lugger. Yards of the Lugger.

His Majefly, for the better difeovering and bringing to Juffice the Perfons concerned in this most atro-cious Outrage and Murder, is hereby pleased to promife His most gracious Pardon to any one of them, (except the jaid Charles Gee) who shall differer his Accomplices therein, fo that Two or more of them may be apprehended and convicted of the faid Offence. And as a further Encouragement, the Commissioners of His Majelty's Cultoms do bereby promife a Reward of ONE HUNDKED POUNDS to any Perfon or Perfons subo that apprehend and take, or caule to be apprehended and taken, the faid Charles Gee, to be paid by the Receiver-General of His Majefty's Cuftoms upon his Convision: And if, in confequence of fuch Difcovery an Apprebenfion, any One or more of the faid Offenders shall be taken, tried, and convicted of the jaid Of-fence, the Person making fuch Discovery shall be entitled to the like Reward.

WHEREAS it bas been bumbly reprefented to the King, That about Seven o'Clock in the Evening of Tuesday the 30th of November last, Ed-ward Holborough, who was fined by Two of His Majesty's Justices of the Peace for the County of Wilts, in the Penalty of Sixty-five Pounds, for bar-bouring Seventy-two Gallons of Spirits, came to the House of Mr. Robert Mann, Saper-visor of Excise, at Corfbam, in the fame County, and paid the faid Fine: That, about Eight o'Clock the fame Evening, a Number of Ruffians came and knocked foftly at the Dopr of the faid Robert Mann, who was flanding in the Kitchen with the Diwision Officer ! That, upon the Door being opened, Seven or Eight Men in Dif-guife, rushed into the House, all armed with Pistols of warious Sizes, and, with borrid Imprecations,

demanded the Money to be delivered up immediately, or they would blow out his the faid Supervisor's Brains; and that Five of them furrounded him with their Piffols pointed at his Head and Body : That, upon the faid Robert Mann's afking them what Money they meant, they faid, the Fine; -- their own---their own: That, upon the faid Robert Mann's declaring he had it not about him, they obliged him to fay where it was; and Four of them forced him up Stairs into his Chamber; and, upon his taking the faid Money out of his Cheft, which was in a Purfe, they pulled the Purfe from his Hands, and emptied the Money into one of their Hats, and ran down Stairs, faying to their Companions, Here it is - Here it is: That they then left the House, mounted their Horses and fired many Pistols as they rode along the Street : That several respectable Neighbours came to their Doors while the Ruffians were in the faid Robert Mann's Houfe, but they were obliged to go in again, the Ruffians threatening them with immediate Death if they did not.

His Majefly, for the better discovering and bring-ing to Justice the Persons concerned in the most daring Outrage and Robbery above mentioned, is hereby pleased to promise His most gracious Pardon to any of the said Persons, who will discover his or her Accomplice or Accomplices therein, fo that he, fhe or they may be apprehended and convicted thereof.
