Then, by the Sovereign's Command, Lieutenant-General Boyd was introduced into the Presence by Sir Hector Munro, the Junior Knight prefent, preceded by the Gentleman-Usher of the Order, with Reverences as before.

The Sword of State was delivered to the Sovereign by Lord Amherst, the Second Knight in Sereight by Lord Anniell, the occent Angel in co-niority, and Lieutenant-General Boyd kneeling, was knighted therewith. Then Sir Jofeph Yorke, the Senior Knight, preferted the Ribbon and Badge to the Sovereign, and His Majeffy put them over the new Knight's Right Shoulder, who being thus inveffed, and having kified His Majeffy's Hand, the Proceffion returned to the Privy Chaniber in the Order above mentioned, Sir Robert Boyd, the new

Knight, preceding. The Ceremony was performed in His Majefty's Clofet, feveral Great Officers of the Court being prefent.

Every Precaution is ferioufly employed here to keep off the Plague, which by the latest Accounts rages at prefent at Tunis, and its Environs, with as much Violence as if it had declared itself in the Midft of Summer. According to those Accounts no less than Thirty-two Thousand People have been. already carried off by this Calamity.

The Earthquakes, which had ceafed Calabria and Sicily for fome Weeks, have again been fentibly felt, and prove a great Discouragement to the Operations carrying on for the Benefit of those afflicted Countries, particularly at Meffina, which has been declared a free Port, and where the Buildings were actually begun.
