The Satisfaction which your Majesty is pleased to express with our Attention to the great Cause of Religion and Virtue, and with our Duty, Loyalty and Attachment to your Majesty's Person and Government, is a fresh and a very powerful Motive to induce us to apply ourselves, with Zeal and Activity, to disfuse among the People committed to our Care the warmest Sentiments of Religion, and the most grateful Sense of your Majesty's mild and constitutional Government.

We receive, with the greatest Satisfaction, the renewed Assurances of your Majesty's constant Resolution to support and maintain the Church of Scotland, as by Law established, in the complete Enjoyment of Her Rights and Privileges, and we rely on
